# Gaps between divisible terms in $a^{2}\left(a^{2}+1\right)$

#### Abstract

Suppose $a^{2}\left(a^{2}+1\right)$ divides $b^{2}\left(b^{2}+1\right)$ with $b>a$. In this paper, we improve a previous result and prove a gap principle, without any additional assumptions, namely $b \gg a(\log a)^{1 / 8} /(\log \log a)^{12}$. We also obtain $b>{ }_{\epsilon} a^{15 / 14-\epsilon}$ under the abc conjecture.


## 1 Introduction and Main Results

We are interested in increasing sequence of positive integers $\left(a_{n}\right)_{n \geq 0}$ with each term dividing the next one (i.e. $\left.a_{n} \mid a_{n+1}\right)$. A simple example is $\left(2^{n}\right)_{n \geq 0}$. Another example is $(n!)_{n \geq 1}$. These are simple recursively defined sequences. It is more interesting and challenging to require each term of the sequence to have a special form. For example, $\left(3^{n}\right)_{n \geq 0}$ has all terms odd. For another special example, let us consider the Fibonacci numbers

$$
F_{1}=1, F_{2}=1, F_{n+1}=F_{n}+F_{n-1} \text { for } n \geq 2
$$

By the well-known fact that $F_{m} \mid F_{n}$ if and only if $m \mid n$, the sequence $\left(F_{2^{n}}\right)_{n \geq 0}$ has all terms of Fibonacci-type and each term dividing the next one. One may restrict the sequence to numbers of the form $n^{2}+1$ or other polynomials, and we are interested in the growth of such sequences. In this paper, we shall focus on numbers of the form $n^{2}\left(n^{2}+1\right)$ and study the following

Question 1 Suppose $a^{2}\left(a^{2}+1\right)$ divides $b^{2}\left(b^{2}+1\right)$. Must it be true that there is some gap between $a$ and $b$ ? More preciously, is it true that $b>a^{1+\epsilon}$ for some small $\epsilon>0$ ?

In [1], the author studied the above question with some additional restrictions on $a$ and $b$. In this paper, we remove all these restrictions and prove

Theorem 2 Let $a$ and $b$ be positive integers with $a<b$. Suppose $a^{2}\left(a^{2}+1\right)$ divides $b^{2}\left(b^{2}+1\right)$. Then

$$
b \gg \frac{a(\log a)^{1 / 8}}{(\log \max (e, \log a))^{12}} .
$$

Recently, Stephen Choi, Peter Lam and the author [2] defined gap principle of order $n$ for polynomials with integer coefficients as follows:

Definition 3 Let $n$ be a positive integer and $f(x)$ be a polynomial with integral coefficients. Consider the set of all positive integers $a_{0}<a_{1}<a_{2}<$ $\ldots<a_{n}$ such that $f\left(a_{i}\right)$ divides $f\left(a_{i+1}\right)$ for $0 \leq i \leq n-1$. We say that $f(x)$ satisfies the gap principle of order $n$ if $\lim a_{n} / a_{0}=\infty$ as $a_{0} \rightarrow \infty$.

Hence, Theorem 2 implies that the polynomial $f(x)=x^{2}\left(x^{2}+1\right)$ satisfies the gap principle of order 1.

Assuming the abc conjecture, we can obtain a better gap result than that in [1], without any extra assumptions.

Theorem 4 Let $a$ and $b$ be positive integers with $a<b$. Suppose $a^{2}\left(a^{2}+1\right)$ divides $b^{2}\left(b^{2}+1\right)$. Then, under the abc conjecture with any small $\epsilon>0$,

$$
b \gg_{\epsilon} a^{15 / 14-\epsilon} .
$$

Thus, this answers question 1 in the affirmative under the abc conjecture. We hope this article would inspire readers to study questions of similar nature.

Some Notations The symbol $a \mid b$ means that $a$ divides $b$. The notations $f(x) \ll g(x)$ and $g(x) \gg f(x)$ are all equivalent to $|f(x)| \leq C g(x)$ for some constant $C>0$. Finally $f(x)=O_{\lambda}(g(x)), f(x)<_{\lambda} g(x)$ or $g(x)>_{\lambda} f(x)$ mean that the implicit constant $C$ may depend on $\lambda$.

## 2 Proof of Theorem 2

Since $a^{2}\left(a^{2}+1\right)$ divides $b^{2}\left(b^{2}+1\right)$, say

$$
t a^{2}\left(a^{2}+1\right)=b^{2}\left(b^{2}+1\right)
$$

for some integer $t>1$. We may assume $t \leq \log a$, for otherwise the theorem is true automatically. Let $D$ be the greatest common divisor of $a$ and $b$. Suppose $a=D x$ and $b=D y$ with $(x, y)=1$, and let $T=\left(D^{2} x^{2}+1, D^{2} y^{2}+1\right)$. Then

$$
\begin{equation*}
t x^{2} \frac{D^{2} x^{2}+1}{T}=y^{2} \frac{D^{2} y^{2}+1}{T} . \tag{1}
\end{equation*}
$$

Since $(x, y)=1, x^{2}$ must divide $\left(D^{2} y^{2}+1\right) / T$. Say $\left(D^{2} y^{2}+1\right) / T=m x^{2}$ for some integer $m$. Then $t\left(D^{2} x^{2}+1\right) / T=m y^{2}$, and we have

$$
\begin{equation*}
t\left(D^{2} x^{2}+1\right)=m T y^{2} \tag{2}
\end{equation*}
$$

and

$$
\begin{equation*}
D^{2} y^{2}+1=m T x^{2} \tag{3}
\end{equation*}
$$

Multiplying (2) by $D^{2}$, (3) by $m T$ and combining, we have

$$
\begin{equation*}
\left[(m T)^{2}-t D^{4}\right] x^{2}=t D^{2}+m T \tag{4}
\end{equation*}
$$

Similarly, multiplying (2) by $m T$, (3) by $t D^{2}$ and combining, we have

$$
\begin{equation*}
\left[(m T)^{2}-t D^{4}\right] y^{2}=t D^{2}+t m T \tag{5}
\end{equation*}
$$

Subtracting (4) from (5), we get

$$
\begin{equation*}
s\left(y^{2}-x^{2}\right)=(t-1) m T \tag{6}
\end{equation*}
$$

with

$$
\begin{equation*}
s=(m T)^{2}-t D^{4} \tag{7}
\end{equation*}
$$

From (3), we have $(m T, D)=1$. Hence,

$$
(s, m T)=\left((m T)^{2}-t D^{4}, m T\right)=\left(t D^{4}, m T\right)=(t, m T) .
$$

Therefore, by combining this with (6), we have $s \mid(t-1) t$ and (7) gives us an hyperelliptic curve

$$
Y^{2}=t X^{4}+s
$$

by setting $Y=m T$ and $X=D$. Let $\lambda:=(t-1) t$. By Theorem 1 of Voutier [3] on the study of integral solutions to hyperelliptic curves using transcendental number theory, we have

$$
\max (X, Y)<e^{C_{1} \lambda(\max (1, \log \lambda))^{96}}
$$

for some constant $C_{1} \geq 1$. Suppose $\lambda \leq \frac{1}{C_{1}} \frac{\log D}{(\log \max (e, \log D))^{96}}$. Then

$$
D=X<e^{C_{1} \frac{1}{C_{1}} \frac{\log D}{(\log \max (e, \log D))^{96}}(\log \max (e, \log D))^{96}}=D
$$

which is a contradiction. Therefore, $(t-1) t>\frac{1}{C_{1}} \frac{\log D}{(\log \max (e, \log D))^{96}}$ and

$$
\begin{equation*}
t \gg \frac{\sqrt{\log D}}{(\log \max (e, \log D))^{48}} \tag{8}
\end{equation*}
$$

From (2), we have $2 t D^{2} x^{2} \geq m T y^{2}$ and $t D^{2} \gg m T$. This together with (4) gives $t D^{2} \gg x^{2}$. Hence, as $t \leq \log a$ and $a=D x$, we have $\log D \gg \log a$. Therefore, (8) gives

$$
t \gg \frac{\sqrt{\log a}}{(\log \max (e, \log a))^{48}}
$$

and we have Theorem 2 as $b^{4} / a^{4} \gg t$.

## 3 Proof of Theorem 4

Firstly, for any integer $n$, let $R(n):=\prod_{p \mid n} p$ be the radical or kernel of an integer $n$. The abc-conjecture is

Conjecture 5 For every $\epsilon>0$, there exists a constant $C_{\epsilon}$ such that for all triples $(a, b, c)$ of coprime positive integers, with $a+b=c$, then

$$
c<C_{\epsilon} R(a b c)^{1+\epsilon} .
$$

Secondly, let us state a lemma which follows easily from the unique prime factorization of numbers.

Lemma 6 Suppose $a \mid A^{2}$ and $a=a_{1} a_{2}^{2}$ with $a_{1}$ squarefree. Then $a_{1} a_{2} \mid A$.

Basically, we follow the proof of Theorem 2. Using the same notation as in section 2,

$$
a=D x, b=D y, \text { and } s+t D^{4}=(m T)^{2}
$$

with $(m T, D)=1$. Let

$$
\left(t,(m T)^{2}\right)=d \text { and } d=d_{1} d_{2}^{2} \text { with } d_{1} \text { squarefree. }
$$

By Lemma 6, we have $m T=d_{1} d_{2} S$. Then

$$
\begin{equation*}
\frac{s}{d}+\frac{t}{d} D^{4}=d_{1} S^{2} \tag{9}
\end{equation*}
$$

Here, the three terms are integers and pairwise relatively prime. We can apply the abc conjecture and obtain

$$
\begin{equation*}
\frac{t}{d} D^{4}<C_{\epsilon}\left(\frac{(t-1) t}{d} D d_{1} S\right)^{1+\epsilon} \tag{10}
\end{equation*}
$$

since $s \mid(t-1) t$. Suppose $t \leq 10 D^{4}$. As $d_{1} \leq d$, (9) gives

$$
\left(d_{1} S\right)^{2} \ll t D^{4} \text { or } d_{1} S \ll t^{1 / 2} D^{2}
$$

Putting this into (10), we have

$$
\frac{t}{d} D^{4} \ll_{\epsilon}\left(\frac{t^{5 / 2}}{d} D^{3}\right)^{1+\epsilon}
$$

Hence,

$$
\begin{equation*}
D \ll_{\epsilon} t^{3 / 2+8 \epsilon} . \tag{11}
\end{equation*}
$$

As $s+t D^{4}=(m T)^{2}, s \mid(t-1) t$ and $t \leq D^{4}$, we have $m T \ll t^{1 / 2} D^{2}$. This together with (4) gives

$$
x^{2} \ll \frac{t D^{2}}{s} \text { or } x \ll t^{1 / 2} D
$$

Therefore, by (11),

$$
a=D x \ll t^{1 / 2} D^{2} \lll_{\epsilon} t^{7 / 2+16 \epsilon} \text { or } t>_{\epsilon} a^{2 / 7-2 \epsilon}
$$

which gives Theorem 4 as $b^{4} / a^{4} \gg t$.
We are left with the case $t>10 D^{4}$. Suppose $y / x=b / a \leq a^{1 / 5}=(D x)^{1 / 5}$. From (1), we have $t^{1 / 4} \leq \sqrt[4]{2} y / x$. Hence,

$$
\begin{equation*}
10 D^{4}<t \leq 2(D x)^{4 / 5} \tag{12}
\end{equation*}
$$

This gives

$$
\begin{equation*}
x>\frac{10}{2^{5 / 4}} D^{4} . \tag{13}
\end{equation*}
$$

On the other hand, (3) and (1) give

$$
m T \leq 2 D^{2} y^{2} / x^{2} \leq 2 \sqrt{2} t^{1 / 2} D^{2}
$$

Putting this into (4), we have

$$
\begin{equation*}
x^{2} \leq(1+2 \sqrt{2}) t D^{2} \text { or } \frac{1}{1+2 \sqrt{2}}\left(\frac{x}{D}\right)^{2} \leq t \tag{14}
\end{equation*}
$$

Combining (12) and (14), we obtain

$$
\frac{1}{1+2 \sqrt{2}}\left(\frac{x}{D}\right)^{2} \leq 2(D x)^{4 / 5} \text { or } x \leq[2(1+\sqrt{2})]^{5 / 6} D^{7 / 3}
$$

which contradicts (13). Therefore, we must have $b / a>a^{1 / 5}$ which also gives Theorem 4.
