# MOMENTS OF QUADRATIC TWISTS OF ELLIPTIC CURVE $L$-FUNCTIONS OVER FUNCTION FIELDS

#### Abstract

We calculate the first and second moments of $L$-functions in the family of quadratic twists of a fixed elliptic curve $E$ over $\mathbb{F}_{q}[x]$, asymptotically in the limit as the degree of the twists tends to infinity. We also compute moments involving derivatives of $L$-functions over quadratic twists, enabling us to deduce lower bounds on the correlations between the analytic ranks of the twists of two distinct curves.


## 1. Introduction and statement of results

The values of $L$-functions at the central point of the critical strip have been the subject of considerable interest in recent years. One way to study these central values is by considering moments in families of $L$-functions. There are now precise conjectured asymptotic formulas for such moments motivated by analogies with Random Matrix Theory KS00a, KS00b. More precise asymptotic formulas containing lower order terms were conjectured in [CFK ${ }^{+} 03$, DGH03, CFK $^{+} 05$. In the case of the Riemann zeta-function, the analogue of these conjectures is now relatively well understood in terms of correlations of the divisor function CK15a, CK15b, CK15c, CK16, CK19]. The moments of other degree-one $L$-functions have also been investigated intensively. It remains a challenge to extend these calculations to $L$-functions of degree two and higher.

The first moment of the family of quadratic twists of a fixed modular form was studied in BFH90a, Iwa90, MM91. Questions related to the nonvanishing of $L$-functions in this family were considered in BFH90a, MM91, BFH90b. For example, it is shown independently in MM91 and BFH90b, using different techniques, that there are infinitely many fundamental discriminants $d<0$ such that for a fixed elliptic curve with root number equal to 1 , its twist by $d$ has analytic rank equal to 1 .

The second moment of the family was considered by Soundararajan and Young in SY10. Unconditionally, they obtained a lower bound for the second moment which matches the asymptotic formula conjectured by Keating and Snaith KS00b and assuming the Generalized Riemann Hypothesis (GRH) they established the conjectured formula. Using similar ideas, again under GRH, Petrow Pet14 obtained several asymptotic formulas for moments of derivatives of these $G L(2) L$-functions when the sign of the functional equation is -1 .

While no asymptotic formulas for moments larger than the second are known for this family, there are lower and upper bounds of the right order of magnitude. Rudnick and Soundararajan [RS05, RS06] established unconditional lower bounds for all moments larger than the first, and, assuming GRH, the work of Soundararajan Sou09 and its refinement by Harper Har13 produced upper bounds of the conjectured order of magnitude. In RS15 Radziwiłł and Soundararajan proved upper bounds for moments below the first in this family of $L$-functions. Their techniques also allow them to obtain a one-sided central limit for the distribution of the logarithm of these central $L$-values. Their result supports a conjecture by Keating and Snaith KS00a which can be viewed as the analogue of Selberg's central limit theorem for the distribution of $\log |\zeta(1 / 2+i t)|$.

In this paper we study several moment problems of comparable difficulty to the moment computation of Soundararajan and Young in the function field family of quadratic twists
of an elliptic curve. Since we are working over function fields, the results we obtain are unconditional.

Recently there has been a good deal of work on computing moments of $L$-functions in the function field setting. Andrade and Keating AK12 obtained an asymptotic formula for the first moment in the symplectic family of quadratic $L$-functions when the degree of the $L$ functions (which is a polynomial in this case) goes to infinity and the size of the finite field is fixed (see also HR92 for a similar result). A lower order term of size approximately the cube root of the main term was computed in Flo17b. The second, third and fourth moments were computed in [Flo17c, Flo17a (see also [Dia18]). We note that the asymptotic formula for the fourth moment does not have a power savings error term, but recovers several of the expected leading order terms in the conjectured formula AK14. Obtaining an asymptotic formula with the leading order term for the fourth moment in the family of quadratic $L$-functions is comparable in difficulty to establishing an asymptotic formula for the second moment of $L$-functions of quadratic twists of an elliptic curve, and is one of the problems we consider in this paper.

We note that for all of our results, we fix the size $q$ of the finite field we work in and let the degree of the $L$-functions go to infinity. If instead one fixes the degree and lets $q \rightarrow \infty$, then Katz and Sarnak [KS99] showed that the $L$-functions become equidistributed in the orthogonal group, and hence computing the various moments reduces to computing several random matrix integrals (see for example [KS00a]). In the case of elliptic curve $L$-functions, the relevant equidistribution results were established in HKRG17.

To state our results we first need some notation. Fix a prime power $q$ with $(q, 6)=1$ and $q \equiv 1(\bmod 4)$. Let $K=\mathbb{F}_{q}(t)$ be the rational function field and $\mathcal{O}_{K}=\mathbb{F}_{q}[t]$. Let $E / K$ be an elliptic curve defined by $y^{2}=x^{3}+a x+b$, with $a, b \in \mathcal{O}_{K}$ and discriminant $\Delta=4 a^{3}+27 b^{2}$ such that $\operatorname{deg}_{t}(\Delta)$ is minimal.

The normalized $L$-function associated to the elliptic curve $E / K$ has the following Euler product and Dirichlet series, which converge for $\Re(s)>1$,

$$
\begin{aligned}
L(E, s):=\mathcal{L}(E, u) & =\sum_{f \in \mathcal{M}} \lambda(f) u^{\operatorname{deg}(f)} \\
& =\prod_{P \mid \Delta}\left(1-\lambda(P) u^{\operatorname{deg}(P)}\right)^{-1} \prod_{P \nmid \Delta}\left(1-\lambda(P) u^{\operatorname{deg}(P)}+u^{2 \operatorname{deg}(P)}\right)^{-1},
\end{aligned}
$$

where we set $u:=q^{-s}$, and $\mathcal{M}$ denotes the set of monic polynomials over $\mathbb{F}_{q}[t]$. The $L$-function is a polynomial in $u$ with integer coefficients of degree

$$
\begin{equation*}
\mathfrak{n}:=\operatorname{deg}(\mathcal{L}(E, u))=\operatorname{deg}(M)+2 \operatorname{deg}(A)-4, \tag{1.1}
\end{equation*}
$$

where for simplicity we denote by $M$ the product of the finite primes with multiplicative reduction and by $A$ the product of the finite primes with additive reduction. Moreover, the $L$-function satisfies the functional equation; namely, there exists $\epsilon(E) \in\{ \pm 1\}$ such that

$$
\mathcal{L}(E, u)=\epsilon(E)(\sqrt{q} u)^{\mathfrak{n}} \mathcal{L}\left(E, \frac{1}{q u}\right) .
$$

For a more precise formula for the sign of the functional equation, see Lemma 2.3 in [BH12]. Now for $D \in \mathcal{O}_{K}$ with $D$ square-free, monic of odd degree and $(D, \Delta)=1$, we consider the twisted elliptic curve $E \otimes \chi_{D} / K$ with the affine model $y^{2}=x^{3}+D^{2} a x+D^{3} b$. Then the $L$-function corresponding to the twisted elliptic curve has the following Dirichlet series and Euler product
$\mathcal{L}\left(E \otimes \chi_{D}, u\right)=\sum_{f \in \mathcal{M}} \lambda(f) \chi_{D}(f) u^{\operatorname{deg}(f)}$

$$
=\prod_{P \mid \Delta}\left(1-\lambda(P) \chi_{D}(P) u^{\operatorname{deg}(P)}\right)^{-1} \prod_{P \nmid \Delta D}\left(1-\lambda(P) \chi_{D}(P) u^{\operatorname{deg}(P)}+u^{2 \operatorname{deg}(P)}\right)^{-1}
$$

The new $L$-function is a polynomial of degree $(\mathfrak{n}+2 \operatorname{deg}(D))$ and satisfies the functional equation

$$
\begin{equation*}
\mathcal{L}\left(E \otimes \chi_{D}, u\right)=\epsilon(\sqrt{q} u)^{\mathfrak{n}+2 \operatorname{deg}(D)} \mathcal{L}\left(E \otimes \chi_{D}, \frac{1}{q u}\right) \tag{1.2}
\end{equation*}
$$

where

$$
\epsilon=\epsilon\left(E \otimes \chi_{D}\right)=\epsilon_{\operatorname{deg}(D)} \epsilon(E) \chi_{D}(M)
$$

Here $\epsilon_{\operatorname{deg}(D)} \in\{ \pm 1\}$ is an integer which only depends on the degree of $D$ (see Proposition 4.3 in [BH12]).

Let $\mathcal{H}_{2 g+1}^{*}$ denote the set of monic, square free polynomials of degree $(2 g+1)$ coprime to $\Delta$. Our first two theorems concern the first and second moments of $L\left(E \otimes \chi_{D}, 1 / 2\right)$.

Theorem 1.1. Unless $\epsilon_{2 g+1} \epsilon(E)=-1$ and $M=1$, we have

$$
\frac{1}{\left|\mathcal{H}_{2 g+1}^{*}\right|} \sum_{D \in \mathcal{H}_{2 g+1}^{*}} L\left(E \otimes \chi_{D}, \frac{1}{2}\right)=c_{1}(M)+O_{\varepsilon}\left(q^{-g+\epsilon g}\right)
$$

where the value $c_{1}(M)$ is defined in (5.6) and (5.2). In particular, the constant $c_{1}(M) \neq 0$ in this case and we obtain an asymptotic formula.

Theorem 1.2. Unless $\epsilon_{2 g+1} \epsilon(E)=-1$ and $M=1$, we have

$$
\frac{1}{\left|\mathcal{H}_{2 g+1}^{*}\right|} \sum_{D \in \mathcal{H}_{2 g+1}^{*}} L\left(E \otimes \chi_{D}, \frac{1}{2}\right)^{2}=c_{2}(M) L\left(\operatorname{Sym}^{2} E, 1\right)^{3} g+O_{\varepsilon}\left(g^{1 / 2+\varepsilon}\right)
$$

where the value $c_{2}(M)$ is defined in (6.2), (3.8) and (3.9). In particular, the constant $c_{2}(M) \neq$ 0 in this case and we obtain an asymptotic formula.

Note that the Theorem above is the function field analogue of Theorem 1.2 in [SY10]. Considering the smoothed second moment, Soundararajan and Young obtain an error term of size $(\log X)^{3 / 4+\epsilon}$, which would translate to $g^{3 / 4+\epsilon}$ in the function field setting. Using slightly different techniques, Petrow states in Pet14 that the error term could be improved to $(\log X)^{1 / 2+\epsilon}$ which is of the same quality we obtain in the result above.

Our Theorem 1.2 should also be compared to the asymptotic formula for the fourth moment of quadratic $L$-functions over function fields in Flo17a. We remark that for the symplectic family of quadratic $L$-functions, one can obtain lower order terms in the asymptotic formula by using an inductive argument and then obtaining upper bounds for moments of $L$-functions evaluated at points far from the critical point. The fact that one can compute a few lower order terms can be explained by the gap between powers of $g$ coming from evaluating moments at the critical point versus evaluating moments far from the critical point. When computing the fourth moment of quadratic $L$-functions close to the central point, one expects to obtain a power of $g^{10}$. As we move away from the central point, the family starts to behave like a family with unitary symmetry and one expects an upper bound of the magnitude $g^{4}$. The difference in powers of $g$ gives one room to use a repetitive argument to rigorously compute lower order terms down to $g^{4}$. In the case of the orthogonal family we consider in this paper, note that the main term in Theorem 1.2 is of size $g$, and the error term has size $g^{1 / 2}$ coming from obtaining an upper bound for the second moment evaluated at a point far from the central point. The small difference between these powers of $g$ does not give us enough room to compute a lower order term in this case.

We can also study the moment of the product of the quadratic twists of two elliptic curve $L$-functions. Let $E_{1}$ and $E_{2}$ be two elliptic curves over $K$. Let $\Delta=\Delta_{1} \Delta_{2}$, where, for $i=1,2$,
$\Delta_{i}$ denotes the discriminant of $E_{i}$. Let $M_{i}$ denote the product of the finite primes with multiplicative reduction and

$$
\epsilon_{i}=\epsilon_{\operatorname{deg}(D)} \epsilon\left(E_{i}\right) \chi_{D}\left(M_{i}\right)
$$

Define

$$
\epsilon_{i}^{+}:=\frac{1+\epsilon_{i}}{2} \quad \text { and } \quad \epsilon_{i}^{-}:=\frac{1-\epsilon_{i}}{2} .
$$

Theorem 1.3. Unless $\epsilon_{2 g+1} \epsilon\left(E_{1}\right)=-1$ and $M_{1}=1$, or $\epsilon_{2 g+1} \epsilon\left(E_{2}\right)=1$ and $M_{2}=1$, or $\epsilon\left(E_{1}\right)=\epsilon\left(E_{2}\right)$ and $M_{1}=M_{2}$, we have

$$
\begin{aligned}
\frac{1}{\left|\mathcal{H}_{2 g+1}^{*}\right|} & \sum_{D \in \mathcal{H}_{2 g+1}^{*}} \epsilon_{2}^{-} L\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right) L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right) \\
& =c_{3}\left(M_{1}, M_{2}\right) L\left(\operatorname{Sym}^{2} E_{1}, 1\right) L\left(\operatorname{Sym}^{2} E_{2}, 1\right) L\left(E_{1} \otimes E_{2}, 1\right) g+O_{\varepsilon}\left(g^{1 / 2+\varepsilon}\right)
\end{aligned}
$$

where the value $c_{3}\left(M_{1}, M_{2}\right)$ is defined in (7.3), (3.8) and (3.10). In particular, the constant $c_{3}\left(M_{1}, M_{2}\right) \neq 0$ in this case and we obtain an asymptotic formula.

Theorem 1.4. Unless $\epsilon_{2 g+1} \epsilon\left(E_{1}\right)=1$ and $M_{1}=1$, or $\epsilon_{2 g+1} \epsilon\left(E_{2}\right)=1$ and $M_{2}=1$, or $\epsilon\left(E_{1}\right)=-\epsilon\left(E_{2}\right)$ and $M_{1}=M_{2}$, we have

$$
\begin{aligned}
\frac{1}{\left|\mathcal{H}_{2 g+1}^{*}\right|} & \sum_{D \in \mathcal{H}_{2 g+1}^{*}} \epsilon_{1}^{-} \epsilon_{2}^{-} L^{\prime}\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right) L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right) \\
& =c_{4}\left(M_{1}, M_{2}\right) L\left(\operatorname{Sym}^{2} E_{1}, 1\right) L\left(\operatorname{Sym}^{2} E_{2}, 1\right) L\left(E_{1} \otimes E_{2}, 1\right) g^{2}+O_{\varepsilon}\left(g^{1+\varepsilon}\right)
\end{aligned}
$$

where the value $c_{4}\left(M_{1}, M_{2}\right)$ is defined in (8.2), (3.8) and (3.10). In particular, the constant $c_{4}\left(M_{1}, M_{2}\right) \neq 0$ in this case and we obtain an asymptotic formula.

Note that this result is the analogue of Theorem 2.2 in Pet14. An interesting problem would be to compute the average of $L\left(E_{1} \otimes \chi_{D}, 1 / 2\right) L\left(E_{2} \otimes \chi_{D}, 1 / 2\right)$ for distinct elliptic curves $E_{1}$ and $E_{2}$. This would have applications to the question of simultaneous non-vanishing of $L\left(E_{1} \otimes \chi_{D}, 1 / 2\right)$ and $L\left(E_{2} \otimes \chi_{D}, 1 / 2\right)$. However our techniques do not allow us to obtain such an asymptotic formula.

Define the analytic rank of a quadratic twist of an elliptic curve $L$-function $L\left(E \otimes \chi_{D}, s\right)$ by

$$
r_{E \otimes \chi_{D}}:=\operatorname{ord}_{s=1 / 2} L\left(E \otimes \chi_{D}, s\right)
$$

Combining the upper bounds for moments of elliptic curve $L$-functions (see Section (4) with Theorems 1.3 and 1.4 leads to the following corollary.
Corollary 1.5. Unless $\epsilon_{2 g+1} \epsilon\left(E_{1}\right)=-1$ and $M_{1}=1$, or $\epsilon_{2 g+1} \epsilon\left(E_{2}\right)=1$ and $M_{2}=1$, or $\epsilon\left(E_{1}\right)=\epsilon\left(E_{2}\right)$ and $M_{1}=M_{2}$, we have

$$
\#\left\{D \in \mathcal{H}_{2 g+1}^{*}: r_{E_{1} \otimes \chi_{D}}=0, r_{E_{2} \otimes \chi_{D}}=1\right\}>_{\varepsilon} \frac{q^{2 g}}{g^{6+\varepsilon}}
$$

as $g \rightarrow \infty$. Also, unless $\epsilon_{2 g+1} \epsilon\left(E_{1}\right)=1$ and $M_{1}=1$, or $\epsilon_{2 g+1} \epsilon\left(E_{2}\right)=1$ and $M_{2}=1$, or $\epsilon\left(E_{1}\right)=-\epsilon\left(E_{2}\right)$ and $M_{1}=M_{2}$, we have

$$
\#\left\{D \in \mathcal{H}_{2 g+1}^{*}: r_{E_{1} \otimes \chi_{D}}=r_{E_{2} \otimes \chi_{D}}=1\right\} \gg_{\varepsilon} \frac{q^{2 g}}{g^{6+\varepsilon}}
$$

as $g \rightarrow \infty$.
As far as we are aware, Corollary 1.5 is the first result in literature where explicit lower bounds concerning the correlations between the ranks of two twisted elliptic curves are obtained. Following Harper's argument for the upper bounds for moments of $L$-functions [Har13], one may remove the exponents $\varepsilon$ in Corollary 1.5. We fail to obtain positive proportions in the
above results because we are not able to use a mollifier. Note that the results of Heath-Brown HB04 adapted to the function field setting do not lead to positive proportions either.

## 2. Some useful Lemmas

In this section we will gather a few useful lemmas we will need throughout the paper.
Recall that $q$ is a prime power with $q \equiv 1(\bmod 4)$ and $(q, 6)=1$. Let $\mathcal{M}$ denote the set of monic polynomials over $\mathbb{F}_{q}[t]$ and $\mathcal{H}$ be the set of monic, square-free polynomials. Let $\mathcal{M}_{n}$ denote the set of monic polynomials of degree $n$ over $\mathbb{F}_{q}[t]$ and $\mathcal{M}_{\leq n}$ be the set of monic polynomials of degree less than or equal to $n$. Let $\mathcal{H}_{n}$ denote the monic, square-free polynomials of degree $n$ and recall that $\mathcal{H}_{n}^{*}$ denotes the set of monic, square-free polynomials of degree $n$ coprime to $\Delta$. The norm of a polynomial $f$ is defined by $|f|=q^{\operatorname{deg}(f)}$.

We define the zeta-function as

$$
\zeta_{q}(s)=\sum_{f \in \mathcal{M}} \frac{1}{|f|^{s}}
$$

for $\Re(s)>1$. By counting monic polynomials of a given degree, one can easily show that

$$
\zeta_{q}(s)=\frac{1}{1-q^{1-s}}
$$

and this provides a meromorphic continuation of $\zeta_{q}$ with a simple pole at $s=1$. As before, we will make the change of variables $u=q^{-s}$ and so the zeta-function becomes

$$
\mathcal{Z}(u)=\zeta_{q}(s)=\sum_{f \in \mathcal{M}} u^{\operatorname{deg}(f)}=\frac{1}{1-q u}
$$

with a simple pole at $u=1 / q$. Note that $\mathcal{Z}(u)$ can also be written as an Euler product

$$
\mathcal{Z}(u)=\prod_{P}\left(1-u^{\operatorname{deg}(P)}\right)^{-1}
$$

where the product is over monic, irreducible polynomials in $\mathbb{F}_{q}[t]$.
The quadratic character over $\mathbb{F}_{q}[t]$ is defined as follows. For $P$ a monic, irreducible polynomial let

$$
\left(\frac{f}{P}\right)= \begin{cases}1 & \text { if } P \nmid f, f \text { is a square modulo } f, \\ -1 & \text { if } P \nmid f, f \text { is not a square modulo } f, \\ 0 & \text { if } P \mid f .\end{cases}
$$

We extend the definition of the quadratic residue symbol above to any $D \in \mathbb{F}_{q}[t]$ by multiplicativity, and define the quadratic character $\chi_{D}$ by

$$
\chi_{D}(f)=\left(\frac{D}{f}\right)
$$

Since we assumed that $q \equiv 1(\bmod 4)$, note that the quadratic reciprocity holds; namely if $A$ and $B$ are two monic coprime polynomials, then

$$
\left(\frac{A}{B}\right)=\left(\frac{B}{A}\right)
$$

Throughout the paper, we will often make use of the Perron formula over function fields. If the series $\sum_{f \in \mathcal{M}} a(f) u^{\operatorname{deg}(f)}$ is absolutely convergent for $|u| \leq r<1$ then

$$
\sum_{f \in \mathcal{M}_{n}} a(f)=\frac{1}{2 \pi i} \oint_{|u|=r}\left(\sum_{f \in \mathcal{M}} a(f) u^{\operatorname{deg}(f)}\right) \frac{d u}{u^{n+1}},
$$

and

$$
\sum_{f \in \mathcal{M}_{\leq n}} a(f)=\frac{1}{2 \pi i} \oint_{|u|=r}\left(\sum_{f \in \mathcal{M}} a(f) u^{\operatorname{deg}(f)}\right) \frac{d u}{u^{n+1}(1-u)} .
$$

Recall that the twisted elliptic curve $L$-function $\mathcal{L}\left(E \otimes \chi_{D}, u\right)$ is a polynomial of degree $(\mathfrak{n}+2 \operatorname{deg}(D))$, with $\mathfrak{n}$ being defined in (1.1). Thus we can write

$$
\mathcal{L}\left(E \otimes \chi_{D}, u\right)=\sum_{n=0}^{\mathfrak{n}+2 \operatorname{deg}(D)} c_{n} u^{n},
$$

where $c_{n}=\sum_{f \in M_{n}} \lambda(f) \chi_{D}(f)$.
Lemma 2.1. The coefficients $c_{n}$ of $\mathcal{L}\left(E \otimes \chi_{D}, u\right)$ satisfy the following relation

$$
c_{n}=\epsilon q^{n-\mathfrak{n} / 2-\operatorname{deg}(D)} c_{\mathfrak{n}+2 \operatorname{deg}(D)-n},
$$

with $\epsilon$ as in equation (1.2). In particular, if $\epsilon=-1$ and $\mathfrak{n}$ is even, then $c_{\mathfrak{n} / 2+\operatorname{deg}(D)}=0$.
Proof. From the functional equation (1.2) we have

$$
\sum_{n=0}^{\mathfrak{n}+2 \operatorname{deg}(D)} c_{n} u^{n}=\epsilon \sum_{n=0}^{\mathfrak{n}+2 \operatorname{deg}(D)} c_{n} q^{\mathfrak{n} / 2+\operatorname{deg}(D)-n} u^{\mathfrak{n}+2 \operatorname{deg}(D)-n}
$$

By setting $k:=\mathfrak{n}+2 \operatorname{deg}(D)-n$ we get

$$
\sum_{n=0}^{\mathfrak{n}+2 \operatorname{deg}(D)} c_{n} u^{n}=\epsilon \sum_{k=0}^{\mathfrak{n}+2 \operatorname{deg}(D)} c_{\mathfrak{n}+2 \operatorname{deg}(D)-k} q^{k-\mathfrak{n} / 2-\operatorname{deg}(D)} u^{k}
$$

Comparing the coefficients we obtain the lemma.
For $D \in \mathcal{H}_{2 g+1}^{*}$, we can obtain the following exact formulas for $L\left(E \otimes \chi_{D}, 1 / 2\right)$ and $L^{\prime}(E \otimes$ $\left.\chi_{D}, 1 / 2\right)$. These are the analogues of the approximate functional equations in the number field setting.

Lemma 2.2. Let $D \in \mathcal{H}_{2 g+1}^{*}$. Then

$$

2.1. Outline of the proof. We will use the approximate functional equations for the $L-$ functions involved in the moment computations and then truncate the Dirichlet series close to the endpoint. For the longer Dirichlet series, we will use Poisson summation and standard techniques to compute the main terms. For the tails, we will go back and write the Dirichlet series in terms of expressions involving moments and then use upper bounds for moments. The key in bounding the tails is the fact that the moments behave differently depending on the points where we evaluate them (the power of $g$ gets smaller in different ranges).

## 3. Main proposition

For $N \mid \Delta^{\infty}$, let

To proceed we need to study the function $\mathcal{B}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right)$.
Lemma 3.5. The function $\mathcal{B}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right)$ defined above may be written as

\mathcal{D}_{2}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right) \mathcal{L}\left(E_{1} \otimes \chi_{C_{1} V_{1}}, \frac{u}{q^{1+\alpha}}\right) \mathcal{L}\left(E_{2} \otimes \chi_{C_{1} V_{1}}, \frac{v}{q^{1+\beta}}\right)
$$

where $\mathcal{D}_{2}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right)$ is some Euler product which is uniformly convergent provided that $|u|,|v| \leq q^{1 / 2-2 / g},|w| \leq q^{-1 / 2-\varepsilon}$, and satisfies

\mathcal{D}_{2}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right) \ll g^{10} \tau_{10}(A B) \sqrt{A B}
$$

uniformly in this region.
Proof. It is easy to see that $\mathcal{B}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right)$ converges absolutely if $|u|,|v| \leq q^{-\varepsilon}$ and $|w| \leq q^{-1 / 2-\varepsilon}$. We claim that the sum over $f, h$ and $V_{2}$ is triply multiplicative. Indeed, one can easily see that the double sum over $f, h$ is multiplicative, so

& =\prod_{P}\left(\sum_{i, j} \frac{\chi_{C_{1}}\left(P^{i+j}\right) \lambda_{1}\left(P^{i+a_{P}}\right) \lambda_{2}\left(P^{j+b_{P}}\right) u^{i \operatorname{deg}(P)} v^{j \operatorname{deg}(P)} G\left(V_{1} V_{2}^{2}, P^{i+j+a_{P}+b_{P}+n_{P}}\right)}{|P|^{(3 / 2+\alpha) i+(3 / 2+\beta) j}}\right)
\end{aligned}
$$

where $a_{P}, b_{P}$ and $n_{P}$ denote the orders of $A, B$ and $N$ with respect to $P$ respectively. Let $A_{P}\left(V_{2}\right)$ denote the Euler product above. Note that when $P \nmid V_{2}$, we have $A_{P}\left(V_{2}\right)=A_{P}(1)$. Then we rewrite the double sum over $f, h$ as

We introduce the sum over $V_{2}$ and use the observation that for $\left(V_{2}, V_{3}\right)=1$ and $P \nmid V_{3}$ we have $A_{P}\left(V_{2} V_{3}\right)=A_{P}\left(V_{2}\right)$. Then

& =\prod_{P}\left(\sum_{i, j, k} \frac{\chi_{C_{1}}\left(P^{i+j}\right) \lambda_{1}\left(P^{i+a_{P}}\right) \lambda_{2}\left(P^{j+b_{P}}\right) u^{i \operatorname{deg}(P)} v^{j \operatorname{deg}(P)} w^{2 k \operatorname{deg}(P)} G\left(V_{1} P^{2 k}, P^{i+j+a_{P}+b_{P}+n_{P}}\right)}{|P|^{(3 / 2+\alpha) i+(3 / 2+\beta) j}}\right)
\end{aligned}
$$

and hence the generating series for $f, h, V_{2}$ is indeed triply multiplicative.
Now we rewrite $\mathcal{B}\left(N, A, B, C_{1}, V_{1} ; u, v, w, \alpha, \beta\right)$ as

& \prod_{P \nmid C_{1}}\left(\sum_{i, j, k} \frac{\chi_{C_{1}}\left(P^{i+j}\right) \lambda_{1}\left(P^{i+a_{P}}\right) \lambda_{2}\left(P^{j+b_{P}}\right) u^{i \operatorname{deg}(P)} v^{j \operatorname{deg}(P)} w^{2 k \operatorname{deg}(P)} G\left(V_{1} P^{2 k}, P^{i+j+a_{P}+b_{P}+n_{P}}\right)}{|P|^{(3 / 2+\alpha) i+(3 / 2+\beta) j}}\right) \\
& \quad \times \prod_{P \mid C_{1}}\left(\sum_{k} \lambda_{1}\left(P^{a_{P}}\right) \lambda_{2}\left(P^{b_{P}}\right) w^{2 k \operatorname{deg}(P)} G\left(V_{1} P^{2 k}, P^{a_{P}+b_{P}+n_{P}}\right)\right) .
\end{aligned}
$$

We next compute the Euler factors at an irreducible $P$ in the region $|u|,|v| \leq q^{1 / 2-2 / g}$, $|w| \leq q^{-1 / 2-\varepsilon}$. Note that in this region, $w^{2 k \operatorname{deg}(P)}<_{\varepsilon}|P|^{-1-\varepsilon}$ if $k \geq 1$.

Consider first the case when $P \nmid N A B C_{1} V_{1}$. The contribution of such an Euler factor is

In view of Lemma 2.5, this is equal to

which justifies the two $L$-functions.
In the case $P \mid V_{1}$ but $P \nmid N A B C_{1}$, the Euler factor equals

&=1-\frac{\lambda_{1}\left(P^{2}\right) u^{2 \operatorname{deg}(P)}}{|P|^{2+2 \alpha}}-\frac{\lambda_{1}(P) \lambda_{2}(P)(u v)^{\operatorname{deg}(P)}}{|P|^{2+\alpha+\beta}}-\frac{\lambda_{2}\left(P^{2}\right) v^{2 \operatorname{deg}(P)}}{|P|^{2+2 \beta}}+O\left(\frac{1}{|P|^{1+\varepsilon}}\right) \\
& \quad=1+O\left(\frac{1}{|P|^{1+2 / g}}\right)
\end{aligned}
$$

Similarly, the corresponding Euler factor is

= \begin{cases}O\left(|P|^{1 / 2}\right) & \text { if } P \mid A B \text { and } P \nmid N C_{1} V_{1}, \\ O(1) & \text { if } P|A B, P| V_{1} \text { and } P \nmid N C_{1}, \\ 1+O\left(\frac{1}{|P|^{1+\varepsilon}}\right) & \text { if } P \mid C_{1} \text { and } P \nmid N A B, \\ O\left(|P|^{1 / 2}\right) & \text { if } P\left|C_{1}, P\right| A B \text { and } P \nmid N V_{1}, \\ 0 & \text { if } P\left|C_{1}, P\right| A B, P \mid V_{1} \text { and } P \nmid N,\end{cases}
$$

and is

if $P \mid N$.
The lemma easily follows by combining these estimates.

We now return to (3.12). In view of Lemma 3.5, we take $r \leq q^{-1 / 2-\varepsilon}$ and move the $u$ and $v$ contours to $|u|=|v|=r q^{1 / 2-2 / g}$. This creates no poles. Then, by the above result,

& \ll g^{10} \tau_{10}(A B) \sqrt{A B}\left(\left|\mathcal{L}\left(E_{1} \otimes \chi_{C_{1} V_{1}}, \frac{u / w}{q^{1+\alpha}}\right)\right|^{2}+\left|\mathcal{L}\left(E_{2} \otimes \chi_{C_{1} V_{1}}, \frac{v / w}{q^{1+\beta}}\right)\right|^{2}\right)
\end{aligned}
$$

So

$$
\begin{aligned}
S(V \neq 0) & \ll q^{2 g-(X+Y) / 2} g^{10} \sum_{\substack{c_{2} \leq Z \\
c_{1}+2 c_{2} \leq 2 g+1}} \sum_{\substack{C_{1} \in \mathcal{M}_{c_{1}} \\
C_{2} \in \mathcal{M}_{c_{2}}}} \frac{\tau(C) \tau_{10}(C) \tau\left(C_{1}\right)}{\sqrt{|C| \mid}\left|C_{1}\right|\left|C_{2}\right|^{2}} \oint_{|u|=q^{1 / 2-1 / g}} \oint_{|v|=q^{1 / 2-1 / g}} \\
& \times \oint_{|w|=r} \sum_{V_{1} \in \mathcal{H}}\left|\mathcal{L}\left(E_{1} \otimes \chi_{C_{1} V_{1}}, \frac{u}{q^{1+\alpha}}\right)\right|^{2} \frac{d u d v d w}{|w|^{X+Y+\operatorname{deg}(N)-\operatorname{deg}\left(V_{1}\right)+c_{1}+2 c_{2}-2 g+1}} .
\end{aligned}
$$

If $\operatorname{deg}\left(V_{1}\right) \leq X+Y+c_{1}+2 c_{2}-2 g$, then we move the $w$ contour to $|w|=q^{-3 / 4}$, otherwise we move the $w$ contour to $|w|=q^{-5 / 4}$. Using the upper bounds for moments as in Theorem 4.1 (see Remark 4.2) we find that

& \ll q^{(X+Y) / 2} g^{11} \sum_{C_{2} \in \mathcal{M}_{\leq Z}} \frac{\tau\left(C_{2}\right) \tau_{10}\left(C_{2}\right)}{\sqrt{\left|\operatorname{rad}\left(C_{2}\right)\right|}} \ll q^{(X+Y+Z) / 2} g^{30},
\end{aligned}
$$

which finishes the proof of Lemma 3.4
Proposition 3.1 follows upon combining the estimates and choosing $Z=g-(X+Y) / 4$.

## 4. UPper bounds for moments

The aim of this section is to bound the tails of the Dirichlet series in the approximate functional equations in Lemmas 2.2 and 2.3. We start with the following upper bounds for moments.

Theorem 4.1. Let $k>0, u=e^{i \theta}, v=e^{i \gamma}$ with $\theta, \gamma \in[0,2 \pi]$ and let $m=\operatorname{deg}\left(\mathcal{L}\left(E \otimes \chi_{D}, w\right)\right)$. Then
$\sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|\mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{q^{1 / 2+\alpha}}\right) \mathcal{L}\left(E \otimes \chi_{D}, \frac{v}{q^{1 / 2+\beta}}\right)\right|^{k}<_{\varepsilon} q^{2 g} g^{\varepsilon} \exp \left(k \mathcal{M}(u, v, m)+\frac{k^{2}}{2} \mathcal{V}(u, v, m)\right)$
uniformly for $|\alpha|,|\beta| \leq \frac{1}{g}$, where $\mathcal{M}(u, v, m)$ and $\mathcal{V}(u, v, m)$ are given by equations (4.9) and (4.11) respectively.

Remark 4.2. Note that the same upper bound as above holds if we replace $\mathcal{L}\left(E \otimes \chi_{D}, w\right)$ with $\mathcal{L}\left(E \otimes \chi_{D \ell}, w\right)$ for a fixed polynomial $\ell$ with $(\ell, \Delta)=1$. Since the proof of the upper bound for this twisted moment is the same as the proof of Theorem 4.1, we only focus on $\ell=1$.

We first need the following proposition, whose proof is similar to the proof of Theorem 3.3 in AT14.

Proposition 4.3. Let $D \in \mathcal{H}_{2 g+1}^{*}$ and let $m=\operatorname{deg}\left(\mathcal{L}\left(E \otimes \chi_{D}, w\right)\right)$. Then for $h \leq m$ and $z$ with $\Re(z) \geq 0$ we have

\log \left|L\left(E \otimes \chi_{D}, \frac{1}{2}+z\right)\right| \leq \frac{m}{h}+\frac{1}{h} \Re\left(\sum_{\substack{j \geq 1 \\ \operatorname{deg}\left(P^{j}\right) \leq h}} \frac{\chi_{D}\left(P^{j}\right)\left(\alpha(P)^{j}+\beta(P)^{j}\right) \log q^{h-j \operatorname{deg}(P)}}{|P|^{j\left(\frac{1}{2}+z+\frac{1}{h \log q}\right) \log q^{j}}}\right) .
$$

Proof. We write

where $\left|\alpha_{j}\right|=1$ (see HKRG17]). Then

We put $s=\sigma+z$ and integrate equation (4.1) with respect to $\sigma$ from $1 / 2$ to $\sigma_{0}$, where $\sigma_{0}>1 / 2$. Taking real parts gives

=\frac{m \log q}{2}\left(\sigma_{0}-\frac{1}{2}\right)-\frac{1}{2 \log q} \sum_{j=1}^{m} \log \frac{q^{\sigma_{0}-1 / 2}-2 q^{-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1 / 2-\sigma_{0}-2 \Re(z)}}{1+q^{-2 \Re(z)}-2 q^{-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)},
$$

where $\alpha_{j}=e^{i \theta_{j}}$. We use the inequality $\log (1+x) \geq x /(1+x)$ for $x>0$ and get that

& \leq \frac{m \log q}{2}\left(\sigma_{0}-\frac{1}{2}\right)-\frac{1}{2 \log q} \sum_{j=1}^{m} \frac{\left(1-q^{1 / 2-\sigma_{0}-2 \Re(z)}\right)\left(1-q^{1 / 2-\sigma_{0}}\right)}{1-2 q^{1 / 2-\sigma_{0}-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1-2 \sigma_{0}-2 \Re(z)}} \\
& \quad=\frac{m \log q}{2}\left(\sigma_{0}-\frac{1}{2}\right)-\frac{G_{z}\left(\sigma_{0}\right)\left(1-q^{1 / 2-\sigma_{0}-2 \Re(z)}\right)\left(1-q^{1 / 2-\sigma_{0}}\right)}{\left(1-q^{1-2 \sigma_{0}-2 \Re(z)}\right) \log q} \tag{4.2}
\end{align*}
$$

where

$$
\begin{equation*}
G_{z}(\sigma)=\frac{1-q^{1-2 \sigma-2 \Re(z)}}{2} \sum_{j=1}^{m} \frac{1}{1-2 q^{1 / 2-\sigma-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1-2 \sigma-2 \Re(z)}} . \tag{4.3}
\end{equation*}
$$

Now similarly as in AT14 we compute the integral

in two different ways. First we write

and integrate term by term. Secondly we continue analytically to the left and pick up the residues. We integrate with respect to $\sigma$ from $\sigma_{0}$ to $\infty$ and take real parts, which gives

& \quad-\frac{1}{(\log q)^{2}} \Re\left(\frac{L^{\prime}}{L}\left(E \otimes \chi_{D}, \sigma_{0}+z\right)\right)+\sum_{j=1}^{m} \Re\left(\int_{\sigma_{0}}^{\infty} \frac{\left(\alpha_{j} q^{1 / 2-\sigma_{0}-z}\right)^{h} \alpha_{j}^{-1} q^{\sigma+z-1 / 2}}{\left(1-\alpha_{j}^{-1} q^{\sigma+z-1 / 2}\right)^{2}} d \sigma\right) .
\end{align*}
$$

Now we have

\Re\left(\int_{\sigma_{0}}^{\infty} \frac{\left(\alpha_{j} q^{1 / 2-\sigma_{0}-z}\right)^{h} \alpha_{j}^{-1} q^{\sigma+z-1 / 2}}{\left(1-\alpha_{j}^{-1} q^{\sigma+z-1 / 2}\right)^{2}} d \sigma\right) \leq \int_{\sigma_{0}}^{\infty} \frac{q^{(1 / 2-\sigma-\Re(z)) h} q^{\sigma+\Re(z)-1 / 2}}{\left|1-\alpha_{j}^{-1} q^{\sigma+z-1 / 2}\right|^{2}} d \sigma \\
=\int_{\sigma_{0}}^{\infty} \frac{q^{(1 / 2-\sigma-\Re(z)) h} q^{1 / 2-\sigma-\Re(z)}}{1-2 q^{1 / 2-\sigma-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1-2 \sigma-2 \Re(z)}} d \sigma .
\end{gathered}
$$

By taking the derivative of

f(x)=\frac{q^{-x}}{1-2 q^{1 / 2-x-\Re(z)} \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1-2 x-2 \Re(z)}}

we can see that $f$ is decreasing on $\left[\sigma_{0}, \infty\right)$. Hence

& \quad \leq \sum_{j=1}^{m} \frac{q^{1 / 2-\sigma_{0}-\Re(z)}}{1-2 q^{1 / 2-\sigma_{0}-\Re(z) \cos \left(\theta_{j}-\log q \Im(z)\right)+q^{1-2 \sigma_{0}-2 \Re(z)}} \int_{\sigma_{0}}^{\infty} q^{(1 / 2-\sigma-\Re(z)) h} d \sigma} \\
& \quad=\frac{2 G_{z}\left(\sigma_{0}\right) q^{\left(1 / 2-\sigma_{0}-\Re(z)\right) h} q^{1 / 2-\sigma_{0}-\Re(z)}}{\left(1-q^{1-2 \sigma_{0}-2 \Re(z)}\right) \log q^{h}} \leq \frac{2 G_{z}\left(\sigma_{0}\right) q^{\left(1 / 2-\sigma_{0}-\Re(z)\right) h}}{\left(\sigma_{0}+\Re(z)-1 / 2\right) \log q \log q^{h}},
\end{aligned}
$$

with $G_{z}\left(\sigma_{0}\right)$ as in equation (4.3). Now from equation (4.1) note that

Combining the equations above and (4.4) gives

& \leq \frac{1}{\log q^{h}} \Re\left(\sum_{n \leq h} \frac{\lambda_{D}(n) \log q^{h-n}}{q^{n\left(\sigma_{0}+z\right)} \log q^{n}}\right)+\frac{1}{h}\left(\frac{m}{2}-G_{z}\left(\sigma_{0}\right)\right)+\frac{2 G_{z}\left(\sigma_{0}\right) q^{\left(1 / 2-\sigma_{0}-\Re(z)\right) h}}{h\left(\sigma_{0}+\Re(z)-1 / 2\right) \log q^{h}}
\end{aligned}
$$

This and (4.2) lead to

$$
\begin{aligned}
& \log \left|L\left(E \otimes \chi_{D}, \frac{1}{2}+z\right)\right| \leq \frac{m}{2 h}+\frac{m \log q}{2}\left(\sigma_{0}-\frac{1}{2}\right)+\frac{1}{\log q^{h}} \Re\left(\sum_{n \leq h} \frac{\lambda_{D}(n) \log q^{h-n}}{q^{n\left(\sigma_{0}+z\right)} \log q^{n}}\right) \\
& \quad+G_{z}\left(\sigma_{0}\right)\left(-\frac{1}{h}+\frac{2 q^{\left(1 / 2-\sigma_{0}-\Re(z)\right) h}}{h\left(\sigma_{0}+\Re(z)-1 / 2\right) \log q^{h}}-\frac{\left(1-q^{1 / 2-\sigma_{0}-2 \Re(z)}\right)\left(1-q^{1 / 2-\sigma_{0}}\right)}{\left(1-q^{1-2 \sigma_{0}-2 \Re(z)}\right) \log q}\right) .
\end{aligned}
$$

Choosing $\sigma_{0}=1 / 2+1 / \log q^{h}$ ensures that the coefficient of $G_{z}\left(\sigma_{0}\right)$ is negative. Since

Before proving Theorem 4.1, we also need the following lemma (see Lemma 8.4 in Flo17a]).

$N(V, u, v)=\left|\left\{D \in \mathcal{H}_{2 g+1}^{*}: \log \left|\mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{q^{1 / 2+\alpha}}\right) \mathcal{L}\left(E \otimes \chi_{D}, \frac{v}{q^{1 / 2+\beta}}\right)\right| \geq V+\mathcal{M}(u, v, m)\right\}\right|$.
We will prove the following lemma.
Lemma 4.5. If $\sqrt{\log m} \leq V \leq \mathcal{V}(u, v, m)$, then

N(V, u, v) \ll q^{2 g+1} \exp \left(-\frac{V^{2}}{2 \mathcal{V}(u, v, m)}\left(1-\frac{12}{\log \log m}\right)\right) ;
$$

if $\mathcal{V}(u, v, m)<V \leq \frac{\log \log m}{13} \mathcal{V}(u, v, m)$, then

N(V, u, v) \ll q^{2 g+1} \exp \left(-\frac{V^{2}}{2 \mathcal{V}(u, v, m)}\left(1-\frac{12 V}{\mathcal{V}(u, v, m) \log \log m}\right)^{2}\right) ;
$$

if $V>\frac{\log \log m}{13} \mathcal{V}(u, v, m)$, then

N(V, u, v) \ll q^{2 g+1} \exp \left(-\frac{V \log V}{4500}\right) .
$$

Using Lemma 4.5 above we can prove Theorem 4.1 as follows.

Proof of Theorem 4.1. We have the following.

& =k \int_{-\infty}^{\infty} \exp (k V+k \mathcal{M}(u, v, m)) N(V, u, v) d V
\end{aligned}
$$

In the equation above we use Lemma 4.5 in the form

which finishes the proof of Theorem 4.1.
Proof of Lemma 4.5. We assume without loss of generality that $\alpha, \beta$ are positive and real. Indeed, notice that if $\alpha \in \mathbb{C}$, since $|\alpha| \leq \frac{1}{g}$, we have $|\Re(\alpha)| \leq \frac{1}{g}$ and $|\Im(\alpha)| \leq \frac{1}{g}$. The proof that follows goes through in exactly the same way, with $\alpha$ replaced by $\Re(\alpha)$ and $\theta$ replaced by $\theta-\Im(\alpha) \log q$. Once we assume $\alpha$ is real, we can also assume that $\alpha$ is positive, since by the functional equation we have

\frac{m}{h}=\frac{V}{A} \quad \text { and } \quad h_{0}=\frac{h}{\log m}

where

A= \begin{cases}\frac{\log \log m}{2} & \text { if } V \leq \mathcal{V}(u, v, m) \\ \frac{\log \log m}{2 V} \mathcal{V}(u, v, m) & \text { if } \mathcal{V}(u, v, m)<V \leq \frac{\log \log m}{13} \mathcal{V}(u, v, m) \\ \frac{13}{12} & \text { if } V>\frac{\log \log m}{13} \mathcal{V}(u, v, m)\end{cases}
$$

Using Proposition 4.3 gives

& \log \left|\mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{q^{1 / 2+\alpha}}\right) \mathcal{L}\left(E \otimes \chi_{D}, \frac{v}{q^{1 / 2+\beta}}\right)\right| \leq \frac{2 m}{h}  \tag{4.5}\\
& +\frac{1}{h} \Re\left(\sum_{\substack{j \geq 1 \\
\operatorname{deg}\left(P^{j}\right) \leq h}} \frac{\chi_{D}\left(P^{j}\right)\left(\alpha(P)^{j}+\beta(P)^{j}\right) \log q^{h-j \operatorname{deg}(P)}}{|P|^{(1 / 2+1 / h \log q) j} \log q^{j}}\left(|P|^{-(\alpha-i \theta / \log q) j}+|P|^{-(\beta-i \gamma / \log q) j}\right)\right)
\end{align*}
$$

Note that the contribution of the terms with $j \geq 3$ is bounded by $O(1)$.
The terms with $j=2$ in (4.5) will contribute, up to a term of size $O(\log \log m)$ coming from those $P$ with $P \mid D$,

Similarly as in Flo17a (Lemma 9.1), we can show that

where for $\theta \in[0,2 \pi]$ we denote $\bar{\theta}=\min \{\theta, 2 \pi-\theta\}$. Now using the fact that

& -\frac{1}{2} \sum_{\operatorname{deg}(P) \leq \frac{h}{2}} \frac{h-2 \operatorname{deg}(P)}{h|P|^{1+2 / h \log q}\left(\frac{\cos (2 \theta \operatorname{deg}(P))}{|P|^{2 \alpha}}+\frac{\cos (2 \gamma \operatorname{deg}(P))}{|P|^{2 \beta}}\right)+O(\log \log m)} \\
& \quad=-\frac{1}{2}\left(F_{\alpha}\left(\frac{h}{2}, \theta\right)+F_{\beta}\left(\frac{h}{2}, \gamma\right)\right)+O(\log \log m) \\
& \quad \leq-\frac{1}{2}\left(F_{\alpha}(m, \theta)+F_{\beta}(m, \gamma)\right)+\frac{2 m}{h}+O(\log \log m)=\mathcal{M}(u, v, m)+\frac{2 m}{h}+O(\log \log m) \tag{4.8}
\end{align*}
$$

where

\begin{equation*}
\mathcal{M}(u, v, m)=-\frac{1}{2}\left(\log \min \left\{m, \frac{1}{\overline{2 \theta}}\right\}+\log \min \left\{m, \frac{1}{\overline{2 \gamma}}\right\}\right) \tag{4.9}

by formula (4.6). Note that in the second line of the equation above we used the fact that

& +\sum_{\operatorname{deg}(P) \leq h} \frac{(h-\operatorname{deg}(P)) \chi_{D}(P) \lambda(P)}{h|P|^{\frac{1}{2}+\frac{1}{h \log q}}}\left(\frac{\cos (\theta \operatorname{deg}(P))}{|P|^{\alpha}}+\frac{\cos (\gamma \operatorname{deg}(P))}{|P|^{\beta}}\right)
\end{aligned}
$$

Let $S_{1}$ be the sum above truncated at $\operatorname{deg}(P) \leq h_{0}$ and $S_{2}$ be the sum over primes with $h_{0}<\operatorname{deg}(P) \leq h$. If $D$ is such that

$$

then

S_{1} \geq V_{1}:=V\left(1-\frac{6}{A}\right) \quad \text { or } \quad S_{2} \geq \frac{V}{A}
$$

Let

$$
\mathcal{F}_{1}=\left\{D \in \mathcal{H}_{2 g+1}^{*}: S_{1} \geq V_{1}\right\} \quad \text { and } \quad \mathcal{F}_{2}=\left\{D \in \mathcal{H}_{2 g+1}^{*}: S_{2} \geq V / A\right\}
$$

If $D \in \mathcal{F}_{2}$, then by Markov's inequality and Lemma 4.4 it follows that

\left|\mathcal{F}_{2}\right| \ll q^{2 g} \frac{(2 l)!}{l!2^{l}}\left(\frac{A}{V}\right)^{2 l}\left(\sum_{h_{0}<\operatorname{deg}(P) \leq h} \frac{|a(P)|^{2}}{|P|}\right)^{l},
$$

for any $l \leq g / h$ where

$$
a(P)=\frac{(h-\operatorname{deg}(P)) \lambda(P)}{h|P|^{\frac{1}{h \log q}}}\left(\frac{\cos (\theta \operatorname{deg}(P))}{|P|^{\alpha}}+\frac{\cos (\gamma \operatorname{deg}(P))}{|P|^{\beta}}\right)
$$

Picking $l=[g / h]$ and noting that $a(P) \ll 1$ and $m=4 g+O(1)$, we get that

\left|\mathcal{F}_{2}\right| \ll q^{2 g}\left(\frac{2 l}{e}\right)^{l}\left(\frac{A}{V}\right)^{2 l}(\log \log m)^{l} \ll q^{2 g} \exp \left(-\frac{V \log V}{8 A}\right) \tag{4.10}
\end{equation*}
$$

If $D \in \mathcal{F}_{1}$ then for any $l \leq g / h_{0}$, we have

\left|\mathcal{F}_{1}\right| \ll q^{2 g} \frac{(2 l)!}{l!2^{l}} \frac{1}{V_{1}^{2 l}}\left(\sum_{\operatorname{deg}(P) \leq h_{0}} \frac{|a(P)|^{2}}{|P|}\right)^{l} .
$$

Using the expression for $a(P)$ and equation (4.7) we get that

\left|\mathcal{F}_{1}\right| \ll q^{2 g} \frac{(2 l)!}{l!2^{l} V_{1}^{2 l}}(\mathcal{V}(u, v, m)+O(\log \log m))^{l}
$$

where

$$
\begin{align*}
& \mathcal{V}(u, v, m)= \log m+ \\
&+\frac{1}{2}\left(F_{\alpha}(m, \theta)+F_{\beta}(m, \gamma)\right)+F_{(\alpha+\beta) / 2}\left(m, \frac{\overline{\theta+\gamma}}{2}\right)+F_{(\alpha+\beta) / 2}\left(m, \frac{\overline{\theta-\gamma}}{2}\right) \\
&=\log m+ \frac{1}{2}\left(\log \min \left\{m, \frac{1}{\overline{2 \theta}}\right\}+\log \min \left\{m, \frac{1}{\overline{2 \gamma}}\right\}\right)  \tag{4.11}\\
&+\log \min \left\{m, \frac{1}{\overline{\theta+\gamma}}\right\}+\log \min \left\{m, \frac{1}{\overline{\theta-\gamma}}\right\}
\end{align*}
$$

and the last line of the equation above follows from equation (4.6). Then

\left|\mathcal{F}_{1}\right| \ll q^{2 g}\left(\frac{2 l}{e V_{1}^{2}}(\mathcal{V}(u, v, m)+O(\log \log m))\right)^{l} .
$$

If $V \leq \mathcal{V}(u, v, m)$, then we pick $l=\left[V_{1}^{2} / 2 \mathcal{V}(u, v, m)\right]$, and if $V>\mathcal{V}(u, v, m)$, then we pick $l=[10 \mathrm{~V}]$. In doing so we get

\left|\mathcal{F}_{1}\right| \ll q^{2 g} \exp \left(-\frac{V_{1}^{2}}{2 \mathcal{V}(u, v, m)}\right)+q^{2 g} \exp (-V \log V) \tag{4.12}

Combining the bounds (4.12) and (4.10) finishes the proof of Lemma 4.5,
The following is an immediate corollary of Theorem 4.1.
Corollary 4.6. Let $u=e^{i \theta}$ and $v=e^{i \gamma}$ with $\theta, \gamma \in[0,2 \pi]$. Then

& \times \min \{g, \overline{\overline{(\theta-\gamma)}}\}^{1 / 2} \min \{g, \overline{\overline{(\theta+\gamma)}}\}^{1 / 2}
\end{aligned}
$$

For $N \mid \Delta^{\infty}$ and fixed $n \in \mathbb{N}$, we define the truncated sums

\mathcal{E}_{2, E}(N, X, n):=\sum_{X<\operatorname{deg}(f) \leq n+\operatorname{deg}(D)} \frac{(n+\operatorname{deg}(D)-\operatorname{deg}(f)) \lambda(f) \chi_{D}(N f)}{\sqrt{|f|}} \tag{4.14}
\end{equation*}
$$

We are now ready to prove the following upper bounds for $\mathcal{E}_{i, E}(N, X, n)$.
Proposition 4.7. For $i=1,2$ and any fixed $n \in \mathbb{N}$ we have

\sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|\mathcal{E}_{i, E}(N, X, n)\right|^{2}<_{\varepsilon} q^{2 g} g^{1 / 2+\varepsilon}(2 g-X)^{2 i} .
$$

Proof. Using the Perron formula for the sum over $f$ in (4.13), we get that

\mathcal{E}_{1, E}(N, X, n)=\frac{\chi_{D}(N)}{2 \pi i} \oint_{|u|=1} \mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{\sqrt{q}}\right)\left(\frac{1}{u^{n+\operatorname{deg}(D)}}-\frac{1}{u^{X}}\right) \frac{d u}{u(1-u)} .
$$

Note that there is no pole at $u=1$. So we need to bound the following expression

$$
\begin{align*}
\frac{1}{(2 \pi i)^{2}} \oint_{|u|=1} \oint_{|v|=1} & \sum_{D \in \mathcal{H}_{2 g+1}^{*}} \mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{\sqrt{q}}\right) \mathcal{L}\left(E \otimes \chi_{D}, \frac{v}{\sqrt{q}}\right) \\
& \times\left(\frac{1}{u^{n+\operatorname{deg}(D)}}-\frac{1}{u^{X}}\right)\left(\frac{1}{v^{n+\operatorname{deg}(D)}}-\frac{1}{v^{X}}\right) \frac{d u d v}{u v(1-u)(1-v)} \tag{4.15}
\end{align*}
$$

We use Corollary 4.6 to bound the integral above and consider $\theta$ and $\gamma$ on different arcs on the unit circle. We bound the integral on these arcs and notice that we obtain the biggest upper bound when $\theta, \gamma$ are not close to 0 (i.e. $u$ and $v$ are not close to 1 ) and when $\theta$ is not close to $\gamma$ or to $2 \pi-\gamma$ (by close we mean on an arc of length on the scale of $1 / g$ ).

For example, if $\theta$ and $\gamma$ are both on an arc $C_{1}$ of length on the scale of $1 / g$ around 0 , then the double integral in (4.15)) over the arcs $C_{1}$ is $O_{\varepsilon}\left(q^{2 g} g^{-1+\varepsilon}\right)$ (since from the Corollary we get a power of $g$ which gets multiplied by $g^{-2}$, the product of the sizes of the arcs.)

If $\theta, \gamma$ are both on the complement of $C_{1}$, but close to each other (i.e. $\theta$ is within $1 / g$ of $\gamma$ ), we get that the corresponding integral over the two arcs is $O_{\varepsilon}\left(q^{2 g} g^{\varepsilon}\right)$. We get a similar bound if $\theta$ is close to $2 \pi-\gamma$, under the same conditions.

We are left with the case when $\theta, \gamma$ are on the complement of $C_{1}$ and $\theta$ is far from $\gamma$ and from $2 \pi-\gamma$. In this case the corresponding integral will be $O_{\varepsilon}\left(q^{2 g} g^{1 / 2+\varepsilon}\right)$. This finishes the proof of the upper bound when $i=1$.

When $i=2$, using the Perron formula for the sum over $f$ in (4.14), we have

\begin{aligned}
\mathcal{E}_{2, E}(N, X, n) & =\frac{\chi_{D}(N)}{2 \pi i} \oint_{|u|=1} \mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{\sqrt{q}}\right) \\
& \times\left(\frac{1}{u^{n+\operatorname{deg}(D)}}-\frac{(n+\operatorname{deg}(D)-X)(1-u)+u}{u^{X+1}}\right) \frac{d u}{(1-u)^{2}} .
\end{aligned}
$$

Hence

\begin{aligned}
\mathcal{E}_{2, E}(N, X, n)^{2}= & \frac{1}{(2 \pi i)^{2}} \oint_{|u|=1} \oint_{|v|=1} \mathcal{L}\left(E \otimes \chi_{D}, \frac{u}{\sqrt{q}}\right) \mathcal{L}\left(E \otimes \chi_{D}, \frac{v}{\sqrt{q}}\right) \\
& \times\left(\frac{1}{u^{n+\operatorname{deg}(D)}}-\frac{(n+\operatorname{deg}(D)-X)(1-u)+u}{u^{X+1}}\right) \\
& \times\left(\frac{1}{v^{n+\operatorname{deg}(D)}}-\frac{(n+\operatorname{deg}(D)-X)(1-v)+v}{v^{X+1}}\right) \frac{d u d v}{(1-u)^{2}(1-v)^{2}} .
\end{aligned}
$$

We proceed as before and keeping in mind that $|u|=|v|=1$, it follows that

\sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|\mathcal{E}_{2, E}(N, X, n)\right|^{2}<_{\varepsilon} q^{2 g} g^{1 / 2+\varepsilon}(2 g-X)^{4},

as required.

## 5. Proof of Theorem 1.1

For $N \mid \Delta^{\infty}$, let

R_{E}(N, X):=\sum_{D \in \mathcal{H}_{2 g+1}^{*}} \sum_{f \in \mathcal{M}_{\leq X}} \frac{\lambda(f) \chi_{D}(N f)}{\sqrt{|f|}}

We will prove the following lemma.
Lemma 5.1. We have

where the value $\mathcal{C}_{E}(N ; 1)$ is defined in (5.2).

\operatorname{deg}\left(C_{2}\right) \leq g}} \frac{1}{\left|C_{2}\right|^{2}}+O_{\varepsilon}\left(q^{\varepsilon g}\right) .
\end{aligned}

We first evaluate $R_{E}(N, X ; V=0)$. From (3.6) we have

Applying the Perron formula to the sum over $f$ yields

We can write $\mathcal{B}_{E}(N ; u)$ in terms of its Euler product,

& =\mathcal{C}_{E}(N ; u) \mathcal{L}\left(\operatorname{Sym}^{2} E, \frac{u^{2}}{q}\right) \tag{5.2}
\end{align*}
$$

where $\mathcal{C}_{E}(N ; u)$ is some Euler product which is uniformly bounded for $|u| \leq q^{1 / 2-\varepsilon}$. We shift the contour in (5.1) to $|u|=q^{1 / 2-\varepsilon}$, encountering a simple pole at $u=1$. Then

& \times \sum_{V \in \mathcal{M}_{\operatorname{deg}(N f)+\operatorname{deg}\left(C_{1}\right)+2 \operatorname{deg}\left(C_{2}\right)-2 g-2}} G(V, N f) .
\end{aligned}
$$

Using the fact that

for $r<1$, and writing $V=V_{1} V_{2}^{2}$ with $V_{1}$ a square-free polynomial, we have

& \times \sum_{\substack{n \leq X \\
n+\operatorname{deg}(N)}} \sum_{\substack{\text { odd }}} \sum_{j \leq n+\operatorname{deg}(N)+c_{1}+2 c_{2}-2 g-2}^{j+c_{1} \text { odd }} \sum_{V_{1} \in \mathcal{H}_{j} V_{2} \in \mathcal{M}_{\left(n+\operatorname{deg}(N)+c_{1}-j\right) / 2+c_{2}-g-1}} \\
& \times \frac{1}{2 \pi i} \oint_{|w|=r} \sum_{f \in \mathcal{M}_{n}} \frac{\chi_{C_{1}}(f) \lambda(f) G\left(V_{1} V_{2}^{2}, N f\right)}{|f|^{3 / 2}} \prod_{P \mid \Delta f}\left(1-w^{\operatorname{deg}(P)}\right)^{-1} \frac{d w}{w^{c_{2}+1}} .
\end{aligned}

Now

\sum_{f \in \mathcal{M}} \frac{\chi_{C_{1}}(f) \lambda(f) G\left(V_{1} V_{2}^{2}, N f\right)}{|f|^{3 / 2}} \prod_{P \mid \Delta f}\left(1-w^{\operatorname{deg}(P)}\right)^{-1} u^{\operatorname{deg}(f)} \\
=\mathcal{H}\left(V_{1} ; u, w\right) \mathcal{I}\left(V_{1} V_{2}^{2}, N ; u, w\right) \mathcal{J}\left(V_{1} V_{2}^{2} ; u, w\right)
\end{gathered}
$$

where

$$
\begin{gathered}
\mathcal{H}\left(V_{1} ; u, w\right)=\prod_{P \nmid V_{1}}\left(1+\frac{\chi_{C_{1} V_{1}}(P) \lambda(P) u^{\operatorname{deg}(P)}}{|P|}\left(1-w^{\operatorname{deg}(P)}\right)^{-1}\right), \\
\mathcal{I}\left(V_{1} V_{2}^{2}, N ; u, w\right)=\prod_{P \mid \Delta}\left(\sum_{j} \frac{\chi_{C_{1}}\left(P^{j}\right) \lambda\left(P^{j}\right) G\left(V_{1} V_{2}^{2}, P^{j+n_{P}}\right) u^{j \operatorname{deg}(P)}}{|P|^{3 j / 2}}\right)\left(1-w^{\operatorname{deg}(P)}\right)^{-1}
\end{gathered}
$$

and

\mathcal{J}\left(V_{1} V_{2}^{2} ; u, w\right)=\prod_{\substack{P \mid V_{1} V_{2} \\ P \nmid}}\left(1+\sum_{j \geq 1} \frac{\chi_{C_{1}}\left(P^{j}\right) \lambda\left(P^{j}\right) G\left(V_{1} V_{2}^{2}, P^{j}\right) u^{j \operatorname{deg}(P)}}{|P|^{3 j / 2}}\left(1-w^{\operatorname{deg}(P)}\right)^{-1}\right)

\times \prod_{\substack{P \nmid V_{1} \\ P \mid \Delta V_{2}}}\left(1+\frac{\chi_{C_{1} V_{1}}(P) \lambda(P) u^{\operatorname{deg}(P)}}{|P|}\left(1-w^{\operatorname{deg}(P)}\right)^{-1}\right)^{-1}
$$

We use the Perron formula for the sum over $f$ and obtain

C_{1} \mid \Delta}} \frac{\mu\left(C_{1}\right) \chi_{C_{1}}(N)}{\left|C_{1}\right|} \\
& \times \sum_{\substack{n \leq X \\
n+\operatorname{deg}(N) \text { odd }}} \sum_{\substack{j \leq n+\operatorname{deg}(N)+c_{1}+2 c_{2}-2 g-2 \\
j+c_{1} \text { odd }}} \sum_{V_{1} \in \mathcal{H}_{j} V_{2} \in \mathcal{M}_{\left(n+\operatorname{deg}(N)+c_{1}-j\right) / 2+c_{2}-g-1}}  \tag{5.4}\\
& \times \frac{1}{(2 \pi i)^{2}} \oint_{|u|=r} \oint_{|w|=r} \mathcal{H}\left(V_{1} ; u, w\right) \mathcal{I}\left(V_{1} V_{2}^{2}, N ; u, w\right) \mathcal{J}\left(V_{1} V_{2}^{2} ; u, w\right) \frac{d u}{u^{n+1}} \frac{d w}{w^{c_{2}+1}} .
\end{align*}
$$

Let $r_{1}=q^{1 / 2-\varepsilon}, r_{2}=q^{-\varepsilon}$, and let $k_{0}$ be minimal such that $\left|r_{1} r_{2}^{k_{0}}\right|<1$. Then we can write

uniformly for $|u| \leq r_{1}$ and $|w| \leq r_{2}$. We also have

in this region. We now move the contours in (5.4) to $|u|=r_{1}$ and $|w|=r_{2}$. We then use the Lindelöf bound for each $L$-function and trivially bound the rest of the expression to obtain that

This finishes the proof of the theorem.

## 6. Proof of Theorem 1.2

Following Lemma 2.2, for $X<2 g$, we define

\end{aligned}
$$

By Cauchy's inequality and Proposition 4.7 we get

+O_{\varepsilon}\left(q^{2 g} g^{1 / 2+\varepsilon}(2 g-X)^{2}\right)
\end{gathered}
$$

Now using Lemma 2.2 again and expanding $\mathcal{M}_{1, E}(X)^{2}$, the first line of the equation above is

\end{aligned}
$$

where recall the definition of $S_{E}(M, X, Y)$ in Section 3.
Using Proposition 3.1, this is equal to

where

c_{2}(M)=2\left(\mathcal{C}_{E}(1 ; 1,1,1)+\epsilon_{2 g+1} \epsilon(E) \mathcal{C}_{E}(M ; 1,1,1)\right) \prod_{P \mid \Delta} \frac{|P|+1}{|P|} \tag{6.2}
\end{equation*}
$$

and $\mathcal{C}_{E}(N ; 1,1,1)$ is defined in (3.9). Thus

\frac{1}{\left|\mathcal{H}_{2 g+1}^{*}\right|} \sum_{D \in \mathcal{H}_{2 g+1}^{*}} L\left(E \otimes \chi_{D}, \frac{1}{2}\right)^{2}=c_{2}(M) L( & \left.\operatorname{Sym}^{2} E, 1\right)^{3} X+O\left(q^{-X / 5} g^{3}\right) \\
& +O\left(q^{-3 g / 4+3 X / 8} g^{30}\right)+O_{\varepsilon}\left(g^{1 / 2+\varepsilon}(2 g-X)^{2}\right)
\end{aligned}
$$

Choosing $X=2 g-100 \log g$ we obtain the theorem.

## 7. Proof of Theorem 1.3

Following Lemma 2.3, for $X<2 g$ and fixed $n \in \mathbb{N}$, we define

\end{align*}
$$

where recall that $\mathcal{E}_{2, E}(M, X, n)$ is given in (4.14). Hence, by combining (6.1) and (7.1),

& \quad-(\log q) \mathcal{M}_{1, E_{1}}(X) \mathcal{M}_{2, E_{2}}\left(X,\left[\mathfrak{n}_{2} / 2\right]\right) \\
& +(\log q)\left(\mathcal{E}_{1, E_{1}}\left(1, X,\left[\mathfrak{n}_{1} / 2\right]\right)+\epsilon_{2 g+1} \epsilon\left(E_{1}\right) \mathcal{E}_{1, E_{1}}\left(M_{1}, X,\left[\left(\mathfrak{n}_{1}-1\right) / 2\right]\right)\right) \\
& \times\left(\mathcal{E}_{2, E_{2}}\left(1, X,\left[\mathfrak{n}_{2} / 2\right]\right)-\epsilon_{2 g+1} \epsilon\left(E_{2}\right) \mathcal{E}_{2, E_{2}}\left(M_{2}, X,\left[\mathfrak{n}_{2} / 2\right]\right)\right)
\end{aligned}
$$

We bound the last term above using Cauchy's inequality and Proposition 4.7. In doing so we get

= & \sum_{D \in \mathcal{H}_{2 g+1}^{*}} \epsilon_{2}^{-} \mathcal{M}_{1, E_{1}}(X) L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right)+(\log q) \sum_{D \in \mathcal{H}_{2 g+1}^{*}} L\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right) \mathcal{M}_{2, E_{2}}\left(X,\left[\mathfrak{n}_{2} / 2\right]\right) \\
& -(\log q) \sum_{D \in \mathcal{H}_{2 g+1}^{*}} \mathcal{M}_{1, E_{1}}(X) \mathcal{M}_{2, E_{2}}\left(X,\left[\mathfrak{n}_{2} / 2\right]\right)+O_{\varepsilon}\left(q^{2 g} g^{1 / 2+\varepsilon}(2 g-X)^{3}\right) \tag{7.2}
\end{align*}
$$

We shall estimate the remaining three terms using Proposition 3.1. They all have similar forms. For the first term, by Lemma 2.3 again we have

h \in \mathcal{M}_{\leq\left[\mathbf{n}_{2} / 2\right]+2 g+1}}} \frac{\left(\left[\mathfrak{n}_{2} / 2\right]+2 g+1-\operatorname{deg}(h)\right) \lambda_{1}(f) \lambda_{2}(h) \chi_{D}(f h)}{\sqrt{|f h|}}
\end{aligned}

By expanding out, this equals

& \left.\quad-\epsilon_{2 g+1} \epsilon\left(E_{2}\right) \mathcal{C}_{E_{1}, E_{2}}\left(M_{2} ; 1,1,1,0,0\right)-\epsilon\left(E_{1}\right) \epsilon\left(E_{2}\right) \mathcal{C}_{E_{1}, E_{2}}\left(M_{1} M_{2} ; 1,1,1,0,0\right)\right) \prod_{P \mid \Delta} \frac{|P|+1}{|P|}

The other two terms in equation (17.2) have the same asymptotics so we obtain

&=c_{3}\left(M_{1},\right.\left.M_{2}\right) L\left(\operatorname{Sym}^{2} E_{1}, 1\right) L\left(\operatorname{Sym}^{2} E_{2}, 1\right) L\left(E_{1} \otimes E_{2}, 1\right) g \\
&+O\left(q^{-3 g / 4+3 X / 8} g^{31}\right)+O_{\varepsilon}\left(g^{1 / 2+\varepsilon}(2 g-X)^{3}\right)

Choosing $X=2 g-100 \log g$ we obtain the theorem.

## 8. Proof of Theorem 1.4

We argue as in the previous section. From (7.1) we have

Bounding the last term above using Cauchy's inequality and Proposition 4.7 leads to

We shall illustrate the evaluation of the third term using Proposition 3.1. The first two terms can be treated in the same way, and in fact they all have the same asymptotics. We have

& \sum_{f, h \in \mathcal{M}_{\leq X}} \frac{\left(\left[\mathfrak{n}_{1} / 2\right]+2 g+1-\operatorname{deg}(f)\right)\left(\left[\mathfrak{n}_{2} / 2\right]+2 g+1-\operatorname{deg}(h)\right) \lambda_{1}(f) \lambda_{2}(h) \chi_{D}(f h)}{\sqrt{|f h|}}

By expanding out, this equals

& \left.\quad-\epsilon_{2 g+1} \epsilon\left(E_{2}\right) S_{E_{1}, E_{2}}\left(M_{2}, X, X ; 0,0\right)+\epsilon\left(E_{1}\right) \epsilon\left(E_{2}\right) S_{E_{1}, E_{2}}\left(M_{1} M_{2}, X, X ; 0,0\right)\right) \\
& +(\log q)\left(\left[\mathfrak{n}_{1} / 2\right]+2 g+1\right) \frac{\partial}{\partial \beta}\left(S_{E_{1}, E_{2}}(1, X, X ; 0, \beta)-\epsilon_{2 g+1} \epsilon\left(E_{1}\right) S_{E_{1}, E_{2}}\left(M_{1}, X, X ; 0, \beta\right)\right. \\

& +(\log q)\left(\left[\mathfrak{n}_{2} / 2\right]+2 g+1\right) \frac{\partial}{\partial \alpha}\left(S_{E_{1}, E_{2}}(1, X, X ; \alpha, 0)-\epsilon_{2 g+1} \epsilon\left(E_{1}\right) S_{E_{1}, E_{2}}\left(M_{1}, X, X ; \alpha, 0\right)\right. \\

& \quad+O(g)+O\left(q^{-3 g / 2+3 X / 4} g^{32}\right)+O_{\varepsilon}\left(g^{1 / 2+\varepsilon}(2 g-X)^{4}\right)
\end{aligned}

Choosing $X=2 g-100 \log g$ we obtain the theorem.

## 9. Proof of Corollary 1.5

The results in Section 4 imply that

\sum_{D \in \mathcal{H}_{2 g+1}^{*}} L\left(E \otimes \chi_{D}, \frac{1}{2}\right)^{4} \ll_{\varepsilon} q^{2 g} g^{6+\varepsilon} . \tag{9.1}
\end{equation*}
$$

We next obtain some upper bounds for moments of the derivatives. We have
$L^{(l)}\left(E \otimes \chi_{D}, \frac{1}{2}\right)^{k}=\left(\frac{l!}{2 \pi i}\right)^{k} \oint \ldots \oint \frac{L\left(E \otimes \chi_{D}, 1 / 2+\alpha_{1}\right) \ldots L\left(E \otimes \chi_{D}, 1 / 2+\alpha_{k}\right)}{\alpha_{1}^{l+1} \ldots \alpha_{k}^{l+1}} d \alpha_{1} \ldots d \alpha_{k}$,
where we are integrating along small circles of radii $r$ around the origin. Then using Hölder's inequality leads to

$$
\sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|L^{(l)}\left(E \otimes \chi_{D}, \frac{1}{2}\right)\right|^{k} \ll \frac{(l!)^{k}}{r^{l k+1}} \oint_{|\alpha|=r} \sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|L\left(E \otimes \chi_{D}, \frac{1}{2}+\alpha\right)\right|^{k} d \alpha
$$

Choosing $r=1 / g$ and using upper bounds for moments of $L$-functions we get that

$$
\sum_{D \in \mathcal{H}_{2 g+1}^{*}}\left|L^{(l)}\left(E \otimes \chi_{D}, \frac{1}{2}\right)\right|^{k} \lll \varepsilon q^{2 g}(l!)^{k} g^{l k+k(k-1) / 2+\varepsilon}
$$

In particular, with $l=1$ and $k=4$, we have

$$
\begin{equation*}
\sum_{D \in \mathcal{H}_{2 g+1}^{*}} L^{\prime}\left(E \otimes \chi_{D}, \frac{1}{2}\right)^{4} \lll \varepsilon q^{2 g} g^{10+\varepsilon} \tag{9.2}
\end{equation*}
$$

Now from Hölder's inequality we have

$$

\left(\sum_{\substack{D \in \mathcal{H}_{2 g+1} \\
\left(D, \Delta_{1}\right)=1}} L\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right)^{4}\right)\left(\sum_{\substack{D \in \mathcal{H}_{2 g+1} \\
\left(D, \Delta_{2}\right)=1}} L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right)^{4}\right)\left(\sum_{\substack{D \in \mathcal{H}_{2 g+1}\left(D, \Delta_{1} \Delta_{2}\right)=1}} 1\right)^{2} \\
\quad \geq\left(\sum_{\substack{D \in \mathcal{H}_{2 g+1} \\
\left(D, \Delta_{1} \Delta_{2}\right)=1}} \epsilon_{2}^{-} L\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right) L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right)\right)^{4}
\end{gathered}
$$

Combining (9.1) and (9.2) with Theorem 1.3 we get

$$
\#\left\{D \in \mathcal{H}_{2 g+1}^{*}: \epsilon_{2}^{-} L\left(E_{1} \otimes \chi_{D}, \frac{1}{2}\right) L^{\prime}\left(E_{2} \otimes \chi_{D}, \frac{1}{2}\right) \neq 0\right\}>_{\varepsilon} \frac{q^{2 g}}{g^{6+\varepsilon}}
$$

which implies the first statement. The second statement can be obtained similarly.
