# NEW ESTIMATES OF THE MAXIMAL BOCHNER-RIESZ OPERATOR IN THE PLANE

ABSTRACT. We prove new  $L^p$ -estimates with 1 for the maximal Bochner-Riesz operator in the plane.

### 1. INTRODUCTION

Bochner-Riesz multiplier operator is defined in  $\mathbb{R}^n$  as

$$T_t^{\lambda} f(x) = (2\pi)^{-n} \int_{\mathbb{R}^n} \left( 1 - \frac{|\xi|^2}{t^2} \right)_+^{\lambda} \widehat{f}(\xi) e^{ix \cdot \xi} d\xi \,,$$

and the associated maximal operator is given by

(1.1) 
$$T_*^{\lambda} f(x) = \sup_{t>0} |T_t^{\lambda} f(x)|.$$

The study of the maximal Bochner-Riesz operator  $T^{\lambda}_{*}$  is closely related to pointwise convergence of the Bochner-Riesz mean  $T^{\lambda}_{t}f$  as  $t \to \infty$ , for any  $f \in L^{p}(\mathbb{R}^{n})$ with 1 . When <math>p > 2, the pointwise convergence phenomena are well understood. For instance, for  $f \in L^{p}(\mathbb{R}^{n})$  with n > 2 and  $p \ge 2$ , the pointwise convergence for  $T^{\lambda}_{t}f$  in the optimal range of  $\lambda$  was shown by Carbery, Rubio de Francia and Vega in [3], via power weighted  $L^{2}$ -estimates. For  $p \ge 2$ , the  $L^{p}$ -estimate of  $T^{\lambda}_{*}$ in planar case is completely settled by Carbery [2], who proved the endpoint case p = 4 for  $T^{\lambda}_{*}$ . The the best known  $L^{p}$ -results with  $p \ge 2$  in the higher dimensional cases is due to Lee [10]. For p > 2, various endpoint bounds for maximal functions associated with radial Fourier multipliers can be found in [11].

However, it remains widely open what the smallest  $\lambda$  shall be in order to make  $T_t^{\lambda} f$  converge to f almost everywhere as  $t \to \infty$ , for any  $f \in L^p(\mathbb{R}^n)$  with 1 .For <math>p between 1 and 2, the pointwise convergence problem, due to Stein's maximal principle [12], is equivalent to build up weak-(p, p) estimate of the maximal Bochner-Riesz operator  $T_*^{\lambda}$ . It was conjectured by Tao [15] that for any  $\lambda > \frac{2n-1}{2p} - \frac{n}{2}$ , the maximal Bochner-Riesz operator  $T_*^{\lambda}$  satisfies  $L^p$  estimate, i.e.,

(1.2) 
$$\left\|T_*^{\lambda}f\right\|_p \lesssim \|f\|_p$$

Tao provided an example proving that (1.2) does not hold for  $\lambda < \frac{2n-1}{2p} - \frac{n}{2}$ . In addition, he proved that in the planar case the  $L^p$  estimate (1.2) holds provided that

(1.3) 
$$\lambda > \max\left\{\frac{3}{4p} - \frac{3}{8}, \frac{7}{6p} - \frac{2}{3}\right\}.$$

Tao's bounds (1.3) can be strengthened as indicated in Figure 1, where the shaded triangular region corresponds to the new estimates we will obtain in this article.

**Theorem 1.1.** Let n = 2 and  $1 . Then (1.2) holds if <math>\lambda$  obeys

(1.4) 
$$\lambda > \lambda_p = \max\left\{\frac{3}{4p} - \frac{3}{8}, \frac{6}{5p} - \frac{7}{10}\right\}.$$

Tao's counterexample shows that (1.2) fail in the region A in Figure 1. As shown in the figure, we only improve Tao's result (1.3) in the range 1 . For<math>10/7 , our result coincides with Tao's. The region B remains open. Weprove Theorem 1.1 by combining Tao's method in [15] with Bourgain-Demeter's $<math>l^2$ -decoupling theorem [1].

Throughout the paper, we use  $a \sim b$  to stand for that  $ca \leq b \leq Ca$  for some unimportant constants c and C. We also use  $a \leq b$  to represent  $a \leq Cb$  for the unimportant constant C. We let M, N be absolute (big) constants and let  $C_{\varepsilon}$  be a constant depending on  $\varepsilon$ . Notice that  $C_{\varepsilon}$  may vary from line to line.

# 2. A STANDARD REDUCTION

Let  $B^n(x, R)$  denote the ball in  $\mathbb{R}^n$ , of radius R, centered at x. We let  $\{\psi_k\}_{k=0}^{\infty}$  form a partition of unity of  $\mathbb{R}^n$  such that  $\psi_0$  is a smooth function supported in  $B^n(0, 2^M)$ ; for  $k \ge 1$ ,  $\psi_k$  is a smooth function supported on the annulus  $A_k = \{x \in \mathbb{R}^n : 2^{k-1+M} \le |x| < 2^{k+1+M}\}$ . It is easy to see that  $\hat{\psi}_k(\xi)$  is concentrated on  $B(0, 2^{1-k-M})$  because  $|\partial^{\alpha}\hat{\psi}_k| \le C_{N_{\varepsilon}} 2^{n(k+1+M)} (1+|2^{k+1+M}\xi|)^{-N_{\varepsilon}}$  for some large  $N_{\varepsilon}$  depends on  $\varepsilon$ , and  $\alpha$  is a multi-index with  $|\alpha| \le N_{\varepsilon}/2$ . We define

(2.1) 
$$\psi_{k,t}(x) = \psi_k(tx)$$

and

(2.2) 
$$K_t^{\lambda}(x) = \int \left(1 - \frac{|\xi|^2}{t^2}\right)_+^{\lambda} e^{ix \cdot \xi} d\xi.$$

Using Fourier inversion formula, we are able to represent

$$T_*^{\lambda} f(x) = \sup_{t>0} \left| \sum_{k\geq 0} (K_t^{\lambda} \psi_{k,t}) * f(x) \right|,$$

which is dominated by, using the triangle inequality,

(2.3) 
$$\sup_{t>0} \left| (K_t^{\lambda} \psi_{0,t}) * f(x) \right| + \sup_{t>0} \left| \sum_{k\geq 1} (K_t^{\lambda} \psi_{k,t}) * f(x) \right|.$$

The first term is controlled by Hardy-Littlewood maximal function and hence it satisfies  $L^p$  estimates. To treat the second term, we recall that the Bochner-Riesz kernel  $K_1^{\lambda}(x)$  has an asymptotic expansion

$$K_1^{\lambda}(x) \approx |x|^{-(n+1)/2-\lambda} \left( e^{i|x|} \sum_{j=0}^{\infty} a_j |x|^{-j} + e^{-i|x|} \sum_{j=0}^{\infty} b_j |x|^{-j} \right)$$

for some constants  $a_j, b_j$  as  $x \to \infty$ . When |x| is sufficiently large, the principal contribution comes from the first term in the asymptotic expansion. Henceforth, it suffices to consider the kernel

(2.4) 
$$\tilde{K}_t^{\lambda}(x) = t^n e^{i|tx|} |tx|^{-(n+1)/2-\lambda}$$

with  $x \neq 0$ , and the associated maximal operator

(2.5) 
$$\tilde{S}_*^{\lambda} f(x) = \sup_{t>0} |\sum_{k\geq 1} (\tilde{K}_t^{\lambda} \psi_{k,t}) * f(x)|.$$

For each k, we define the  $\tilde{S}_{*,k}^{\lambda}$  as

(2.6) 
$$\tilde{S}_{*,k}^{\lambda} f(x) = \sup_{t>0} |(\tilde{K}_t^{\lambda} \psi_{k,t}) * f(x)|.$$

We shall point out that the cutoff function  $\psi_{k,t}$  below may vary from line to line, but they are essentially the same function, since the derivative behaviors as well as the Fourier support behaviors for different  $\psi_{k,t}$ 's remain the same.

It is easy to see that

(2.7) 
$$\|\tilde{S}_{*,k}^{\lambda_p}f\|_{p,\infty} \le C_{\varepsilon} 2^{\varepsilon k} \|f\|_p$$

for any  $\varepsilon > 0$  implies that for  $\lambda > \lambda_p^{-1}$ 

(2.8) 
$$||T_*^{\lambda}f||_{p,\infty} \lesssim ||f||_p$$

following from  $|\tilde{S}_{*,k}^{\lambda}f| \lesssim 2^{-k(\lambda-\lambda_p)} |\tilde{S}_{*,k}^{\lambda_p}f|$  and summing up all the positive k's.

Now let us focus on the plane  $\mathbb{R}^2$  by taking n = 2. Let a(x, y, t) be a smooth function supported on the region  $|x - y| \sim \delta^{-1}, |x|, |y| \leq \delta^{-1}$  and  $t \sim 1$ . Here  $x, y \in \mathbb{R}^2$ . We define

(2.9) 
$$Sf(x,t) = \delta^{3/2} \int e^{it|x-y|} f(y) a(x,y,t) dy,$$

and

(2.10) 
$$S^*f(x) = \sup_{t \sim 1} \left| Sf(x,t) \right|.$$

We introduce one more notation in order to state our technical proposition. Write  $A \leq B$  if  $A \leq C_{\beta} \delta^{-\beta} B$  for some  $\beta$  much smaller than  $\varepsilon$ . The following result allows us to reduce the  $L^p$ -estimate of the maximal Bochner-Riesz operator to a local  $L^p$  estimate of the maximal operator  $S^*$ .

Proposition 2.1. Suppose that

(2.11) 
$$\|S^*f\|_{p,\infty} \lesssim_{\varepsilon} \delta^{-\lambda_p} \delta^{-\varepsilon} \|f\|_p$$

for any  $f \in L^p$ . Then

(2.12)  $\|\tilde{S}_{*,k}^{\lambda_p}f\|_{p,\infty} \lesssim_{\varepsilon} 2^{\varepsilon k} \|f\|_p.$ 

Proposition 2.1 was proved by Tao [14]. For the convenience of readers, we provide a proof in the appendix, similar to Tao's argument. Applying Proposition 2.1, we see that (2.11) implies  $L^p$ -estimate of  $T^{\lambda}_*$  if  $\lambda > \lambda_p$ . To conclude our main result, Theorem 1.1, via an interpolation argument which will be presented below, it suffices to prove the following estimate.

**Proposition 2.2.** Let  $S^*$  be in (2.10) and let E be any measurable set in  $\mathbb{R}^2$ . Then (2.13)  $\|S^*\chi_E\|_{2,\infty} \lesssim \delta^{5/18} |E|^{13/18}$ .

Let us see first how to use (2.13) to conclude Theorem 1.1. Passing to the duality of weak type norm, we have

(2.14) 
$$\sup_{0 < |F| < \infty} |F|^{-1/2} \int_{\mathbb{R}^2} (S^* \chi_E)(x) \cdot \chi_F(x) dx \lesssim \|S^* \chi_E\|_{2,\infty}$$

Since the support of  $S^*\chi_E$  is contained in  $B^2(0, C\delta^{-1})$ , we can assume  $F \subset B^2(0, C\delta^{-1})$ . Using (2.13) and  $|F| \leq C\delta^{-2}$ , we have

(2.15) 
$$\delta^{1-2/p'} \sup_{0 < |F| < \infty} |F|^{-1/p'} \int_{\mathbb{R}^2} (S^* \chi_E)(x) \cdot \chi_F(x) dx \lesssim \delta^{5/18} |E|^{13/18}$$

<sup>1</sup>One can check this by writing  $||f||_{p,\infty}$  in the dual form

$$||f||_{p,\infty} \sim \sup_{0 < |E| < \infty} |E|^{-1/p'} \int f\chi_E$$

where 1/p' + 1/p = 1. See [6] Chapter 1.4

for  $p = \frac{18}{13}$ . Passing back to the weak type norm by duality, we thus have

(2.16) 
$$\|S^*\chi_E\|_{\frac{18}{13},\infty} \lesssim \delta^{-1/6}|E|^{13/18}$$

Notice that we have a standard  $L^2$  estimate by a  $TT^*$ -method (See Lemma 4.1 for instance)

(2.17) 
$$||S^*\chi_E||_2 \lesssim |E|^{1/2}$$

Moreover, by inserting absolute values into the integral (2.9), we get trivially

(2.18) 
$$||S^*\chi_E||_1 \lesssim \delta^{-1/2}|E|_1$$

Now we can invoke the real interpolation between (2.16) and (2.17) for the range 18/13 to obtain

(2.19) 
$$\|S^*f\|_p \lesssim \delta^{-(\frac{3}{4p} - \frac{3}{8})} \|f\|_p \text{ if } \frac{18}{13}$$

In addition, interpolating between (2.16) and (2.18) for 1 , we get

(2.20) 
$$||S^*f||_p \lesssim \delta^{-(\frac{6}{5p} - \frac{7}{10})} ||f||_p, \text{ if } 1$$

(2.11) follows from (2.19) and (2.20). Therefore we can conclude Theorem 1.1 by Proposition 2.1.

Proposition 2.2 is our main result. Sections 3 and 4 are devoted to the proof of Proposition 2.2.

### 3. Model operator and its $L^p$ -estimates

From now on we shall focus on the operators S and  $S^*$  defined in (2.9) and (2.10), respectively. The maximal operator  $S^*$  can be linearized as

(3.1) 
$$S^*f(x,t) = Sf(x,t(x))$$

for some measurable function t(x) taking values ~ 1. Notice that, if we restricted tin a  $\delta$ -neighbourhood, the operator |Sf(x,t)| behaves essentially the same, because x, y are restricted in a  $\delta^{-1}$ -ball. This can be rigorously proved by using Taylor's expansion of the exponential function  $e^{it|x-y|}$ . Thus we are led to partition the interval I = [1, 2] into  $\delta^{-1}$  many subintervals  $I_j$ , of length  $\delta$ . Let  $t_j$  denote the center of  $I_j$  and define

(3.2) 
$$F_j = \left\{ x \in B^2(0, \delta^{-1}) : t(x) \in I_j \right\}.$$

Clearly,  $F_j$ 's are disjoint mutually. Then we see that

(3.3) 
$$S^*f(x,t) = \sum_j Sf(x,t(x))\chi_{F_j}(x) \sim \sum_j Sf(x,t_j)\chi_{F_j}(x).$$

Here we can replace t(x) by  $t_j$  because  $t(x) - t_i = O(\delta)$  when  $t(x) \in F_j$ . Henceforth, we will focus on the right side of (3.3), which is the principal contribution of  $S^*f(x,t)$ . We run into some non-linear operators because  $F_j$ 's depend on f. But the non-linearity will not cause any trouble because there is no any interpolation argument used for the non-linear operators in our proof.

Now for each j, the Fourier transform of the kernel  $\delta^{3/2} e^{it_j|x|}$  is essentially supported in the  $\delta$ -neighborhood of the circle center at 0 with radius  $t_j$ , with a bounded

 $L^{\infty}$  norm. We see that the Fourier transform of  $Sf(x,t_j)$  concentrates on a  $\delta$ neighborhood of the circle  $\{\xi \in \mathbb{R}^2 : |\xi| = t_j\}$ , up to a negligible contribution, because outside of the  $\delta$ -neighborhood, the Fourier transform of  $S(f,t_j)$  decays rapidly as the frequency variable stays away from the origin. Hence we know that the main contribution in frequency space comes from those  $\xi$  lying in the the annulus  $\{\xi \in \mathbb{R}^2 : t_j - \delta \leq |\xi| \leq t_j + \delta\}$ , that can be partitioned into  $\delta^{-1/2}$  many congruent pieces, each of which is essentially a  $\delta^{1/2} \times \delta$  rectangle. We use  $\Omega_j$  to denote the collection of those disjoint  $\delta^{1/2} \times \delta$  rectangles, whose union is essentially the annulus mentioned above. For each  $\omega \in \Omega_j$ , a rectangle is called *dual* to  $\omega$ if its longer side is perpendicular to the longer side of  $\omega$ , and its dimensions are  $\delta^{-1/2} \times \delta^{-1}$ . We further break the physical space into  $\delta^{-1/2} \times \delta^{-1}$  dual rectangles R's.  $R \times \omega$  is called a tile. We use c(R) to denote the center of the rectangle R. For any  $\omega$  and given coordinate axes of  $\mathbb{R}^2$  generated by sides of  $\omega - c(\omega)$ , we can represent it by  $\omega = \omega_1 \times \omega_2$  where  $\omega_1$  is an interval of length  $\delta^{1/2}$  and  $\omega_2$  is an interval of length  $\delta$ . Let

$$\widehat{\varphi_{\omega}}(\xi_1,\xi_2) = \prod_{k=1}^2 \frac{1}{|\omega_k|^{1/2}} \widehat{\varphi}(\frac{\xi_k - c(\omega_k)}{|\omega_k|}) \,.$$

Here  $(\xi_1, \xi_2)$  is the coordinates of  $\xi$  under the given coordinate axes mentioned above, and  $\varphi$  is a Schwartz function from  $\mathbb{R}$  to  $\mathbb{R}$  whose Fourier transform is nonnegative, supported in a small interval, of length  $\kappa$  (a fixed small constant), about the origin in  $\mathbb{R}$ , and identically 1 on another smaller interval around the origin. For any tile  $s = R_s \times \omega_s$ , we define a function  $\varphi_s$  adapted to the tile s by

(3.4) 
$$\widehat{\varphi_s}(\xi) = e^{2\pi i c(R) \cdot \xi} \widehat{\varphi_\omega}(\xi) \,.$$

Let  $\mathbf{S}_j$  be the collection of all possible tiles  $R \times \omega$ 's with  $\omega \in \Omega_j$ . Up to a negligible contribution, we end up with a wavepacket representation of  $Sf(x, t_j)$ ,

(3.5) 
$$Sf(x,t_j) \approx \sum_{s \in \mathbf{S}_j} \langle f, \varphi_s \rangle \varphi_s(x) \,.$$

Such a wavepacket representation can be proved directly as in [7] (Page 30) or by employing inductively the one-dimensional result in [8] (Page 698).

We shall clarify the meaning of  $\approx$  in (3.5). In fact, in a rigorous way, one gets  $Sf(x,t_j) = c \sum_s \langle f, \varphi_s \rangle S\varphi_s(x,t_j)$  by the wavepacket decomposition of f. The function  $S\varphi_s(x,t_j)$  behaves similar to the function  $\varphi_s$ , since both of them have Fourier transforms supported in  $\omega_s$  and they are essentially equal to the modulation factor  $e^{2\pi i c(\omega_s) \cdot x}$  times an  $L^2$ -normalized bump function on  $R_s$ . This is the reason why we are able to replace the  $S\varphi_s(x,t_j)$  by  $\varphi_s$  and end up with the wavepacket representation of (3.5).

Combining (3.5) with (3.3), we see that

(3.6) 
$$|S^*f(x,t)| \approx \left|\sum_j \sum_{s \in \mathbf{S}_j} \langle f, \varphi_s \rangle \varphi_s(x) \chi_{F_j}(x)\right| := \left|Tf(x)\right|.$$

Here the operator T is our model operator which we shall study carefully in this section.

We introduce a positive parameter  $\beta_1$  to split the model operator into two parts. For any positive number  $\beta_1$ , we set

(3.7) 
$$\mathbf{B}_1 = \left\{ s \in \bigcup_j \mathbf{S}_j : \left| \langle f, \varphi_s \rangle \right| < \beta_1 \right\}$$

and

(3.8) 
$$\mathbf{B}_2 = \left\{ s \in \bigcup_j \mathbf{S}_j : \left| \langle f, \varphi_s \rangle \right| \ge \beta_1 \right\}.$$

We further break Tf into  $T_1f + T_2f$ , where

(3.9) 
$$T_k f(x) = \sum_j \sum_{s \in \mathbf{S}_j \cap \mathbf{B}_k} \langle f, \varphi_s \rangle \varphi_s(x) \chi_{F_j}(x)$$

for  $k \in \{1, 2\}$ . We will estimate  $T_1 f$  and  $T_2 f$  in  $L^6$  space and  $L^1$  space, respectively.

Lemma 3.1. Let  $f \in L^2$ . Then

(3.10) 
$$\int |T_1 f|^6 dx \lesssim \delta^2 \beta_1^4 ||f||_2^2$$

*Proof.* The proof relies on the Bourgain-Demeter's  $l^2$ -decoupling theorem [1]. Let us state their result in  $\mathbb{R}^2$  here.

**Theorem 3.2** (Bourgain-Demeter). Let S be a parabola  $\{(\xi, \xi^2) : |\xi| \leq 1\}$  in  $\mathbb{R}^2$ . Let  $\mathcal{N}_{\delta}$  stand for  $\delta$ -neighbourhood of S and let  $P_{\delta}$  be the finite overlapping cover of  $\mathcal{N}_{\delta}$  using curved region  $\theta = \{(\xi, c + \xi^2) : \xi \in I_{\theta}, |c| \leq 2\delta\}$ , where  $I_{\theta}$  is a  $\delta^{1/2}$ -lattice interval contained in [-1, 1]. Denote by  $f_{\theta}$  the Fourier restriction of f to  $\theta$ . If  $supp(\widehat{f}) \subset \mathcal{N}_{\delta}(S)$ , then for any  $\beta > 0$ , we have

(3.11) 
$$||f||_{6} \leq C_{\beta} \delta^{-\beta} \Big( \sum_{\theta \in P_{\theta}} ||f_{\theta}||_{6}^{2} \Big)^{1/2}$$

From Theorem 3.2 we obtain

(3.12) 
$$\int |T_1 f|^6 dx \le C_\beta \delta^{-\beta} \sum_j \left( \sum_{\omega \in \Omega_j} \| \sum_{\substack{s \in \mathbf{S}_j \cap \mathbf{B}_1 \\ \omega_s = \omega}} \langle f, \varphi_s \rangle \varphi_s \|_6^2 \right)^3,$$

which is bounded by, following from Hölder's inequality,

(3.13) 
$$C_{\beta}\delta^{-\beta}\delta^{-1}\sum_{j}\sum_{\omega\in\Omega_{j}}\left\|\sum_{\substack{s\in\mathbf{S}_{j}\cap\mathbf{B}_{1}\\\omega_{s}=\omega}}\langle f,\varphi_{s}\rangle\varphi_{s}\right\|_{6}^{6},$$

since there are  $O(\delta^{-1/2})$  many  $\omega$ 's in each  $\Omega_j$ .

The functions  $\varphi_s$ 's are supported essentially in  $R_s$ 's, which are pairwise disjoint if  $\omega_s$ 's are fixed as  $\omega$ . Thus, we see that

$$(3.13) \lessapprox \delta^2 \sum_{s \in \bigcup_j \mathbf{S}_j \cap \mathbf{B}_1} \left| \langle f, \varphi_s \rangle \right|^6 \lesssim \delta^2 \beta_1^4 \sum_s \left| \langle f, \varphi_s \rangle \right|^2 \lesssim \delta^2 \beta_1^4 ||f||_2^2,$$

yielding the desired estimation (3.10).

We now introduce the second parameter  $\beta_2$  to be chosen later. Let E be a given measurable set in  $\mathbb{R}^2$  and let  $\mathcal{Q}$  be a collection of maximal dyadic cubes Q's such that

$$|E \cap Q| \ge \beta_2 |Q|^{1/2}$$

We set

(3.14) 
$$\tilde{E} = E \setminus \bigcup_{Q \in \mathcal{Q}} Q$$

**Lemma 3.3.** Suppose that  $f \in L^2$  is supported in  $\tilde{E}$ . Then

(3.15) 
$$||T_2f||_1 \lesssim \beta_1^{-1} \delta^{-1/4} \beta_2 ||f||_2^2$$

*Proof.* Inserting absolute values and using the definition of  $\mathbf{B}_2$ , we get

(3.16) 
$$|T_2 f(x)| \lesssim \beta_1^{-1} \sum_j \sum_{s \in \mathbf{S}_j} |\langle f, \varphi_s \rangle|^2 |\varphi_s(x)| \chi_{F_j}(x).$$

Taking  $L^1$ -norm for both sides, we have

(3.17) 
$$\|T_2 f\|_1 \lesssim \beta_1^{-1} \delta^{3/4} \sum_j \sum_{s \in \mathbf{S}_j} |\langle f, \varphi_s \rangle|^2 |R_s \cap F_j|.$$

The right side of (3.17) can be represented as

$$\beta_1^{-1} \delta^{3/4} \int \int f(x) \overline{f(y)} K(x,y) dx dy \,,$$

where the kernel K is given as

(3.18) 
$$K(x,y) = \chi_{\tilde{E}}(x)\chi_{\tilde{E}}(y)\sum_{j}\sum_{s\in\mathbf{S}_{j}}\varphi_{s}(x)\overline{\varphi_{s}(y)}\big|R_{s}\cap F_{j}\big|.$$

It is clear that (3.15) follows from

(3.19) 
$$\int \int f(x)\overline{f(y)}K(x,y)dxdy \le \|f\|_2 \Big(\int \left|\int K(x,y)f(y)dy\right|^2 dx\Big)^{1/2}$$

and

(3.20) 
$$\int |K(x,y)| dy \lesssim \beta_2 \delta^{-1}$$

by employing Schur's test for the operator given by  $\int K(x,y)f(y)dy$ .

We now turn to a proof of (3.20). From the definition of  $\varphi_s$ , we see that  $|\varphi_s(x)|$  satisfies

(3.21) 
$$|\varphi_s(x)| \le |R_s|^{-1/2} \chi_{R_s} + \sum_{k=1}^{\infty} 2^{-1000k} |2^k R_s|^{-\frac{1}{2}} \chi_{2^k R_s}(x),$$

where  $2^k R_s$  is a  $2^k$ -dilation of  $R_s$ . Due to the fast decay factor  $2^{-1000k}$ ,  $|\varphi_s(x)|$  can be treated as  $|R_s|^{-1/2}\chi_{R_s}$ . Therefore, up to a negligible term which can be treated similarly, we have

(3.22) 
$$\int |K(x,y)| dy \lesssim \delta^{3/2} \chi_{\tilde{E}}(x) \int \sum_{j} \sum_{s \in \mathbf{S}_j} \chi_{R_s}(x) \overline{\chi_{R_s}(y)} |R_s \cap F_j| \chi_{\tilde{E}}(y) dy.$$

We use  $\Theta$  to denote the set consisting of all possible directions of  $R_s$ 's. Here the direction of a rectangle means direction of its longer side. Clearly there are at most  $O(\delta^{-1/2})$  many elements in  $\Theta$ . For any  $\theta \in \Theta$ , we tile  $\mathbb{R}^2$  by  $\delta^{-1/2} \times$   $\delta^{-1}$ -rectangles with direction  $\theta$ . Let  $\mathcal{R}_{\theta}$  denote the collection of all possible such rectangles. Involving Fubini's theorem and (3.22), we have

$$(3.23) \quad \int |K(x,y)| dy \lesssim \delta^{3/2} \chi_{\tilde{E}}(x) \int \sum_{\theta \in \Theta} \sum_{R \in \mathcal{R}_{\theta}} \chi_{R}(x) \overline{\chi_{R}(y)} \sum_{j} |R \cap F_{j}| \chi_{\tilde{E}}(y) dy.$$

Using the disjointness of  $F_j$ 's, we see that

(3.24) 
$$\int |K(x,y)| dy \lesssim \chi_{\tilde{E}}(x) \int \sum_{\theta \in \Theta} \sum_{R \in \mathcal{R}_{\theta}} \chi_{R}(x) \overline{\chi_{R}(y)} \chi_{\tilde{E}}(y) dy.$$

The localization argument allows us to focus on only those R contained in a  $\delta^{-1}$ ball in  $\mathbb{R}^2$ . Hence we can restrict the region of y in a  $\delta^{-1}$ -neighborhood of x. We partition this neighborhood into annuli  $A_k(x) = \{y : |y - x| \sim 2^k\}$ 's,  $k \leq \log \delta^{-1}$ . Then

$$\int \sum_{\theta \in \Theta} \sum_{R \in \mathcal{R}_{\theta}} \chi_R(x) \overline{\chi_R(y)} \chi_{\tilde{E}}(y) dy \lesssim \sum_{k \le \log \delta^{-1}} \int_{A_k(x) \cap \tilde{E}} \sum_{\theta \in \Theta} \sum_{R \in \mathcal{R}_{\theta}} \chi_R(x) \overline{\chi_R(y)} dy.$$

The crucial observation is that given x, y with  $|x - y| \sim 2^k$ , there are at most  $O(\min\{\delta^{-1/2}, \delta^{-1}2^{-k}\})$  many  $(\theta, R) \in \Theta \times \mathcal{R}_{\theta}$  such that  $x \in R$  and  $y \in R$ . This is because for each  $\theta$ , there are at most O(1) many R's containing both x and y, and the total number of  $\theta$ 's that contribute to  $\chi_R(x)\chi_R(y)$  is bounded above by  $O(\min\{\delta^{-1/2}, \delta^{-1}2^{-k}\})$ . Therefore we can bound

(3.25) 
$$\int |K(x,y)| dy \lesssim \sum_{k \le \log \delta^{-1}} \min\{\delta^{-1/2}, \delta^{-1}2^{-k}\} |A_k(x) \cap \tilde{E}|.$$

Observe that  $A_k(x)$  can be covered by O(1) many dyadic  $2^k$ -cubes, say Q's. Recalling the definition (3.14) of  $\tilde{E}$ , we see that

(3.26) 
$$|A_k(x) \cap \tilde{E}| \lesssim \sum_Q |Q \cap \tilde{E}| \lesssim \beta_2 2^k$$

because only those Q with  $|Q \cap E| \leq \beta_2 |Q|^{1/2}$  meet the set  $\tilde{E}$  due to the definition of  $\tilde{E}$ . Putting (3.25) and (3.26) together, we obtain

$$\int |K(x,y)| dy \lesssim \sum_{k \le \log \delta^{-1}} \beta_2 \min \left\{ \delta^{-1/2} 2^k, \delta^{-1} \right\} \lesssim \beta_2 \delta^{-1},$$

yielding the desired (3.20), from which (3.15) follows by Schur's test.

## 4. Proof of Proposition 2.2

We provide a proof of Proposition 2.2 in this section. First we state a local  $L^2$  result, which was proved by Tao [15] via a use of  $TT^*$  method.

**Lemma 4.1.** Let  $Q \subset B^2(0, \delta^{-1})$  be a cube, and  $\psi_Q(x)$  be the bump function on Q. Then

(4.1) 
$$\left\| S^*(\psi_Q f) \right\|_2 \lesssim \delta^{1/2} |Q|^{1/4} \|f\|_2$$

holds for any  $f \in L^2$ .

We aim to control  $\|S^*\chi_E\|_{18/13,\infty}$ . Clearly it follows from the triangle inequality that

(4.2) 
$$S^* \chi_E \le S^* \chi_{E \setminus \tilde{E}} + S^* \chi_{\tilde{E}} ,$$

We now prove a weak  $L^2$  estimate for  $S^*\chi_{E \setminus \tilde{E}}$ .

**Lemma 4.2.** For any  $\alpha > 0$ ,

(4.3) 
$$\left| \{ x \in \mathbb{R}^2 : S^* \chi_{E \setminus \tilde{E}}(x) \ge \alpha \} \right| \lesssim \alpha^{-2} \delta \beta_2^{-1} |E|^2.$$

*Proof.* By the triangle inequality and use the local  $L^2$  estimate (4.1), we have

$$||S^*(\chi_{E\setminus\tilde{E}})||_2 \lesssim ||S^*(\sum_{Q\in\mathcal{Q}}\chi_{E\cap Q})||_2 \lesssim \sum_{Q\in\mathcal{Q}}||S^*(\chi_{E\cap Q})||_2$$
$$\lesssim \sum_{Q\in\mathcal{Q}}\delta^{1/2}|Q|^{1/4}|E\cap Q|^{1/2} \lesssim \sum_{Q\in\mathcal{Q}}\delta^{1/2}\beta_2^{-1/2}|E\cap Q| = \delta^{1/2}\beta_2^{-1/2}|E|.$$

Thus, from the Chebyshev inequality (4.3) follows.

On the other hand, from (3.10), we get

(4.4) 
$$\left|\left\{x \in \mathbb{R}^2 : \left|T_1\chi_{\tilde{E}}\right| \ge \alpha\right\}\right| \lesssim \alpha^{-6} \delta^2 \beta_1^4 |E|.$$

From (3.15), we see that

(4.5) 
$$\left|\left\{x \in \mathbb{R}^2 : \left|T_2\chi_{\tilde{E}}\right| \ge \alpha\right\}\right| \lesssim \alpha^{-1}\beta_1^{-1}\delta^{-1/4}\beta_2|E|.$$

Using (4.2), (3.6), (4.3), (4.4) and (4.5), we end up with (4.6)  $|\{x \in \mathbb{R}^2 : |S^*\chi_E(x,t)| \ge \alpha\}| \lesssim \alpha^{-2}\delta\beta_2^{-1}|E|^2 + \alpha^{-1}\beta_1^{-1}\delta^{-1/4}\beta_2|E| + \alpha^{-6}\delta^2\beta_1^4|E|.$ 

We can optimize (4.6) by taking

$$\beta_1 = \alpha \delta^{-13/36} |E|^{1/9}, \quad \beta_2 = \delta^{4/9} |E|^{5/9}.$$

Therefore we have

(4.7) 
$$\|S^*\chi_E\|_{2,\infty} \lesssim \delta^{5/18} |E|^{13/18}$$

which completes the proof of Proposition 2.2.

### 5. Appendix

In this section we present a proof for Proposition 2.1. We only focus on 1 .It is sufficient to prove the following weak type estimate with <math>n = 2.

**Lemma 5.1.** Let  $\psi_{k,t}$  and  $\tilde{K}_t^{\lambda_p}$  be defined as in (2.1) and (2.4), respectively. Assume (2.11) is true and  $1 . Then for <math>k \ge 1$ ,  $\alpha > 0$ ,

(5.1) 
$$\left| \{ x \in \mathbb{R}^n : \sup_{t>0} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * f(x) \right| \ge \alpha \} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} \alpha^{-p} \| f \|_p^p.$$

The proof of (5.3) is based on a standard Carlderón-Zygmund type argument. In this article, we only need to use the result (5.1) in the planar case n = 2. However, the method below works for general n and this is the reason why we employ n instead of 2.

Since the operator  $\tilde{S}_{*,k}^{\lambda_p}$  defined in (2.6) is a sub-linear operator, we can absorb the magnitude  $\alpha$  into f, so that it suffices to show

(5.2) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{t>0} \left| \left( \tilde{K}_t^{\lambda_p} \psi_{k,t} \right) * f(x) \right| \ge 1 \right\} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} ||f||_p^p.$$

For some technical reasons, we will instead prove

(5.3) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{t>0} \left| \left( \tilde{K}_t^{\lambda_p} \psi_{k,t} \right) * f(x) \right| \ge C \right\} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} ||f||_p^p.$$

Here C is an absolute big constant depends on  $\varepsilon$ . In fact, C only depends on our choice of the partition of unity (2.1). The desired estimate (5.2) follows from (5.3) since the operator  $\tilde{S}_{*,k}^{\lambda_p}$  is sub-linear.

Now we begin to prove (5.3). Let  $J_j$  be the time interval  $[2^j, 2^{j+1}], j \in \mathbb{Z}$ . Partitioning  $\mathbb{Z}$  into residue classes mod 2k, we can write

(5.4) 
$$\mathbb{R}^+ = \bigcup_{j \in \mathbb{Z}} J_j = \bigcup_{0 \le r \le 2k-1} \bigcup_{m \in \mathbb{Z}} J_{2km+r}$$

With a translation argument, we can treat  $\bigcup_m J_{2km+r}$  similarly for different r. Thus, by losing 2k, which can be absorbed in  $2^{\varepsilon k}$  in summation over r, it suffices to consider the case r = 0, that is,

(5.5) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{t \in \bigcup_m J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * f(x) \right| \ge C \right\} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} ||f||_p^p$$

Next we adapt a Calderon-Zygmund decomposition on  $|f|^p$  at level 1 to get<sup>2</sup>

$$f = g + \sum_{Q} b_Q,$$

where

$$(5.6) ||g||_{\infty} \lesssim 1$$

$$(5.7) \qquad \qquad \operatorname{supp}(b_Q) \subset Q$$

and

(5.8) 
$$||b_Q||_p \lesssim |Q|^{1/p}.$$

Here Q's are maximal dyadic cubes and we use Q to denote the collection of all possible Q's. Moreover,  $b_Q$  satisfies the moment conditions

(5.9) 
$$\int_{\mathbb{R}^n} b_Q(x) x^r dx = 0, \qquad 0 \le |r| \le N,$$

where r is a multi-index in  $(\mathbb{N} \cup \{0\})^n$ . In the rest of the section, we use c(Q) to denote the center of Q, and  $2^{l(Q)}$  to stand for the side length of the dyadic cube Q.

Because of (5.6) and  $p \in (1,2)$ , we see that  $\|g\|_2^2 \lesssim \|g\|_p^2$ . In addition, the operator  $\tilde{K}_t^{\lambda_p} \psi_{k,t} * g$  is bounded in  $L^2$  for  $\lambda_p > 0$ . Following from the Chebyshev

inequality, it is easy to see that the contribution from the function g satisfies the desired estimate. Henceforth, it remains to prove

(5.10) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{m \in \mathbb{Z}} \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in \mathcal{Q}} b_Q \right)(x) \right| \ge C \right\} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} \sum_{Q \in \mathcal{Q}} |Q|.$$

For fixed m, we sort  $Q \in \mathcal{Q}$  in terms of the size l(Q) by letting

 $\mathcal{Q} = E_{k,m}^1 \cup E_{k,m}^2 \cup E_{k,m}^3,$ 

where  $E_{k,m}^1 = \{Q \in \mathcal{Q} : l(Q) \leq -2km - k\}, E_{k,m}^2 = \{Q \in \mathcal{Q} : -2km - k < l(Q) \leq -2km + k\}$ , and  $E_{k,m}^3 = \{Q \in \mathcal{Q} : -2km + k < l(Q)\}$ . As a result, we only need to prove (5.10) with  $\mathcal{Q}$  replaced by  $E_{k,m}^j, i = 1, 2, 3$ .

We first work on  $E_{k,m}^3$ . Recall that the kernel  $\tilde{K}_t^{\lambda_p} \psi_{k,t}$  equals to

(5.11) 
$$t^{n}e^{i|tx|}|tx|^{-(n+1)/2-\lambda}\psi_{k}(tx)$$

Hence for fixed m,  $\operatorname{supp}(\tilde{K}_t^{\lambda_p}\psi_{k,t}) \subset B^n(0, C2^{k-2km})$ . This implies the support of  $(\tilde{K}_t^{\lambda_p}\psi_{k,t}) * b_Q$  is contained in  $\bigcup_Q CQ$ , where CQ is the cube centered at c(Q) and with side length  $C2^{l(Q)}$ . Combining with the following equation

(5.12) 
$$\begin{cases} x \in \mathbb{R}^n : \sup_{m \in \mathbb{Z}} \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^3} b_Q \right)(x) \right| \ge C \\ \end{bmatrix} \\ = \bigcup_{m \in \mathbb{Z}} \left\{ x \in \mathbb{R}^n : \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^3} b_Q \right)(x) \right| \ge C \right\}, \end{cases}$$

we then have

(5.13) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{m \in \mathbb{Z}} \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^3} b_Q \right)(x) \right| \ge C \right\} \right| \lesssim \sum_{Q \in \mathcal{Q}} |Q|,$$

as desired, because the set in the left side is a subset of  $\cup_{Q \in Q} CQ$ .

Next, we consider  $E_{k,m}^1$ . We will use the moment conditions (5.9) and aim to show the set

(5.14) 
$$\left\{ x \in \mathbb{R}^n : \sup_{m \in \mathbb{Z}} \sup_{t \in J_{2km}} \left| \left( \tilde{K}_t^{\lambda_p} \psi_{k,t} \right) * \left( \sum_{Q \in E_{k,m}^1} b_Q \right)(x) \right| \ge C \right\}$$

is an empty set. As a consequence, (5.10) follows with  $\mathcal{Q}$  replaced by  $E_{k,m}^1$ . Since the equation (5.12) is true for  $E_{k,m}^3$  replaced by  $E_{k,m}^1$ , it suffices to show that for fixed  $m \in \mathbb{Z}$ ,

(5.15) 
$$\left\{ x \in \mathbb{R}^n : \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^1} b_Q \right)(x) \right| \ge C \right\} = \emptyset.$$

To see why (5.15) makes sense, let us take a quick look at what the moment conditions give us in the frequency space. First, (5.9) yields that  $(D^r \hat{b}_Q)(0) = 0$  for  $|r| \leq N$ , where D is the differential operator in  $\mathbb{R}^n$ . This tells us that intuitively,

in a small neighbourhood of 0,  $\hat{b}_Q(\xi) \approx 0$ . On the other hand, observe that the Fourier support of  $\tilde{K}_t^{\lambda}\psi_{k,t}$  is concentrated in the ball  $B^n(0, 2km)$ . The radius of the ball  $B^n(0, 2km)$  is small compare to  $l(Q)^{-1}$ , for  $Q \in E_{k,m}^1$ . Therefore, via Fourier inverse formula, the pointwise value  $|\tilde{K}_t^{\lambda}\psi_{k,t} * b_Q(x)|$  should be small, from which we see that (5.15) does make sense.

We now turn to our rigorous argument for making a proof of (5.15). By a translation argument, without loss of generality, we assume Q is centered at the origin. Abbreviating l(Q) as l and using Taylor's formula, we see that for multiindices  $r_1, r_2 \in (\mathbb{N} \cup \{0\})^n$ ,  $|r_1| = N - 1$ ,  $|r_2| = N$ , we have

(5.16) 
$$|(D^{r_1}\widehat{b}_Q)(\xi)| \le |\xi| \cdot ||D^{r_2}\widehat{b}_Q||_{\infty} \le |\xi| \cdot \int |x|^{|r_2|} |b_Q| dx \le |\xi| \cdot 2^{lN} ||b_Q||_1.$$

From Hölder's inequality we have

 $||b_Q||_1 \le ||\chi_Q||_{p'} ||b_Q||_p \lesssim |Q|,$ 

which, together with (5.16), implies

$$(5.17) \qquad \qquad |(D^{r_1}\widehat{b}_Q)(\xi)| \lesssim |\xi| \cdot 2^{lN} |Q|$$

Noticing  $(D^r \hat{b}_Q)(0) = 0$  for  $|r| \leq N$ , we expand  $\hat{b}_Q(\xi)$  into its Taylor series at 0 and use the remainder formula for the (N-1)-th term to get

$$(5.18) \qquad \qquad |\widehat{b}_Q(\xi)| \lesssim |\xi|^N 2^{lN} |Q|.$$

On the other hand, we calculate the Fourier transform of the kernel  $\tilde{K}_t^{\lambda_p} \psi_{k,t}$  to see

(5.19) 
$$\left|\widehat{\tilde{K}_{t}^{\lambda_{p}}\psi_{k,t}}(\xi)\right| \approx 2^{-\lambda_{p}k} \left|\widehat{\psi}\left(\frac{|\xi| - 2^{2km}}{2^{2km}2^{-k}}\right)\right|.$$

Here the right side of (5.19) is the principal contribution of the Fourier transform of  $\tilde{K}_t^{\lambda_p}\psi_{k,t}$ . It follows from the pointwise estimate  $|\hat{\psi}(|\xi|)| \leq (1+|\xi|)^{-M}$  that for  $|\xi|$  much larger than  $2^{2km}$ ,

(5.20) 
$$|\widehat{\tilde{K}_t^{\lambda_p}\psi_{k,t}}(\xi)| \lesssim \left(\frac{|\xi| - 2^{2km}}{2^{2km}2^{-k}}\right)^{-M}$$

We choose M > 2N and N much larger than n. Since  $(\tilde{K}_t^{\lambda_p} \psi_{k,t}) * b_Q$  is supported in  $B(0, C2^{k-2km})$ , combining (5.18) and (5.20), we obtain the pointwise estimate

$$(5.21) \quad |(\tilde{K}_t^{\lambda_p}\psi_{k,t}) * b_Q(x)| \quad \lesssim \quad ||\widehat{K}_t^{\widehat{\lambda_p}}\psi_{k,t}\widehat{b}_Q||_1\chi_{B^n(c(Q),C2^{-2km+k})}(x) \\ \lesssim \quad 2^{lN}2^{2kmN}2^{2kmn}|Q|\chi_{B^n(c(Q),C2^{-2km+k})}(x).$$

Since the dyadic cubes in  $E_{k,m}^1$  are mutually disjoint, for fixed x, there are at most  $O(2^{-2kmn+kn}|Q|^{-1})$  many cubes Q's of length  $2^l$  that make contribution to the sum  $\sum_{Q \in E_{k,m}^1} (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * b_Q(x)$ . Hence, we can sum up all the Q's with  $l(Q) = 2^l$  and invoke (5.21) to have

(5.22) 
$$\sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^1, l(Q) = 2^l} b_Q \right) (x) \right| \lesssim 2^{lN} 2^{2kmN} 2^{kn}.$$

Finally, as N is much larger than n, we can sum up all the l's with  $l \leq -2km-k$  to get the following pointwise estimate

(5.23) 
$$\sup_{t\in J_{2km}} \left| \left( \tilde{K}_t^{\lambda_p} \psi_{k,t} \right) * \left( \sum_{Q\in E_{k,m}^1} b_Q \right)(x) \right| \lesssim 2^{-kN/2}.$$

This pointwise estimate shows that if we choose C large enough, the set

(5.24) 
$$\left\{ x \in \mathbb{R}^n : \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^1} b_Q \right)(x) \right| \ge C \right\}$$

is an empty set, uniformly for all  $m \in \mathbb{Z}$ . Henceforth, we finish the proof of (5.15), from which (5.14) follows.

Finally, it remains to show the estimate (5.10) with  $\mathcal{Q}$  replaced by  $E_{k,m}^2$ . Since (5.12) holds for  $E_{k,m}^2$  as well, we only need to show the following estimate for a single  $m \in \mathbb{Z}$ 

(5.25) 
$$\left| \left\{ x \in \mathbb{R}^n : \sup_{t \in J_{2km}} \left| (\tilde{K}_t^{\lambda_p} \psi_{k,t}) * \left( \sum_{Q \in E_{k,m}^2} b_Q \right) \right| \ge C \right\} \right| \lesssim_{\varepsilon} 2^{\varepsilon k} \sum_{Q \in E_{k,m}^2} |Q|.$$

Without loss of generality, we can assume for free that all  $Q \in E_{k,m}^2$ 's have the same size because l(Q) taking at most O(k) many values between -2km - k and -2km + k. Thus we have the disjointness property of those Q's in  $E_{k,m}^2$  and now it is clear that

(5.26) 
$$\left\|\sum_{Q\in E_{k,m}^2} b_Q\right\|_p^p \lesssim \sum_{Q\in E_{k,m}^2} |Q|$$

by (5.8). Hence, (5.25) follows from a dilation argument and the following stronger result

(5.27) 
$$\| \sup_{t \in [1,2]} |(\tilde{K}_t^{\lambda_p} \psi_{k,t}) * f| \|_p \lesssim_{\varepsilon} 2^{\varepsilon k} \|f\|_p.$$

(5.27) is a consequence of (2.11). Indeed, let  $\varphi_1(t)$  be a smooth function supported on [3/4, 9/4], taking value 1 for  $t \in [1, 2]$ . As a result, we can replace the kernel  $\tilde{K}_t^{\lambda_p}\psi_{k,t}$  by  $\varphi_1(t)\tilde{K}_t^{\lambda_p}\psi_{k,t}$  in (5.27). Notice that in the planar case, when f is supported  $B^2(0, \delta^{-1})$ , the function  $(\varphi_1(t)\tilde{K}_t^{\lambda_p}\psi_{k,t}) * f$  is morally  $\delta^{\lambda_p}Sf(x,t)$  in (2.9), with  $\delta = 2^{-k}$ . Via a standard localization trick on the support of f(x), we see that (2.11) implies (5.27). Therefore, we finish the proof of (5.1).
