

## INFORMATION FOR AUTHORS

The IEEE TRANSACTIONS ON COMPONENTS, PACKAGING, AND MANUFACTURING TECHNOLOGY publishes research and application articles on modeling, design, building blocks, technical infrastructure, and analysis underpinning electronic, photonic and MEMS packaging, in addition to new developments in passive components, electrical contacts and connectors, thermal management, and device reliability; as well as the manufacture of electronics parts and assemblies, with broad coverage of design, factory modeling, assembly methods, quality, product robustness, and design-for-environment.

The articles in this journal are peer reviewed in accordance with the requirements set forth in the IEEE PSPB Operations Manual (sections 8.2.1.C & 8.2.2.A). Each published article was reviewed by a minimum of two independent reviewers using a single-blind peer review process, where the identities of the reviewers are not known to the authors, but the reviewers know the identities of the authors. Articles will be screened for plagiarism before acceptance.

Corresponding authors from low-income countries are eligible for waived or reduced open access APCs.

### CONTENT

The technical content of articles should be both new and significant. Experimental data should be complete and include sufficient descriptions of experimental apparatus, methods, and relevant experimental conditions. Original, unpublished articles are preferred. However, an article presented at a conference or published in a limited-circulation journal or proceedings may be considered for this TRANSACTIONS if the topic warrants and previous circulation does not substantially duplicate that of this TRANSACTIONS. For articles presented at a conference, the author should do the following.

- 1) Make significant additions/modification to the article. This could include: new data and detailed analysis of the experimental results; addition of references to the previous work of others (not previous work by the authors); a discussion of the previous work and how the author's work expands or builds on it; a discussion of how the author's results compare/contrast the previous work; etc.
- 2) Reference the previously published article in the reference section (this is an IEEE requirement).
- 3) Change the title to reflect the fact that the article has been "significantly" modified.

### PREPARATION AND SUBMISSION

All manuscripts must be submitted through the online system at: <http://mc.manuscriptcentral.com/ieee-tcpmt>. Detailed information on manuscript preparation, review process, final publication, and other topics can be found in the IEEE Author Center at <https://ieeearcher.ieee.org>.

**ORCID Required:** All IEEE journals require an Open Researcher and Contributor ID (ORCID) for all authors. ORCID is a persistent unique identifier for researchers and functions similarly to an article's Digital Object Identifier (DOI). ORCIDs enable accurate attribution and improved discoverability of an author's published work. The author will need a registered ORCID in order to submit a manuscript or review a proof in this journal. To create an ORCID, please visit: <https://orcid.org/register>.

**Author Names in Native Languages:** IEEE supports the publication of author names in the native language alongside the English versions of the names in the author list of an article. For more information, please visit the IEEE Author Center.

**Abstract Description and Specifications:** The abstract must be a concise yet comprehensive reflection of what is in your article. In particular:

- The abstract must be self-contained, without abbreviations, footnotes, or references. It should be a microcosm of the full article.
- The abstract must be between 150–250 words. Be sure that you adhere to these limits; otherwise, you will need to edit your abstract accordingly.
- The abstract must be written as one paragraph, and should not contain displayed mathematical equations or tabular material.
- The abstract should include three or four different keywords or phrases, as this will help readers to find it. It is important to avoid overrepetition of such phrases as this can result in a page being rejected by search engines.
- Ensure that your abstract reads well and is grammatically correct.

**For Letters Submission:** The technical content of articles must be both new and significant.

**Manuscript Length:** The standard length for an accepted manuscript must not exceed 4 pages. The 4th page is reserved exclusively for references in order to accommodate a comprehensive reference list of pre-published and to-be-published articles with full authors names, title, and DOI (where available).

**Graphical Abstract:** This journal accepts graphical abstracts and they must be peer reviewed. For more information about graphical abstracts and their specifications, please visit the IEEE Author Center.

### PROFESSIONAL EDITING SERVICE (REFINING ENGLISH USAGE)

TRANSACTIONS volunteer Reviewers and Editors are not responsible for providing editing services as part of the manuscript review process.

English language editing services can help refine the language of your article and reduce the risk of rejection without review. IEEE authors are eligible for discounts at several language editing services; visit the IEEE Author Center to learn more. Please note these services are fee-based and do not guarantee acceptance.

### OPEN ACCESS

This publication is a hybrid journal, allowing either Traditional manuscript submission or Open Access (author-pays OA) manuscript submission. Upon submission, if you choose to have your manuscript be an Open Access article, you commit to pay the discounted \$2,045 OA fee if your manuscript is accepted for publication in order to enable unrestricted public access. Any other application charges (such as over-length page charge and/or charge for the use of color in the print format) will be billed separately once the manuscript formatting is complete but prior to the publication. If you would like your manuscript to be a Traditional submission, your article will be available to qualified subscribers and purchasers via IEEE Xplore. No OA payment is required for Traditional submission.

### OVERLENGTH PAGE CHARGES

A mandatory Overlength Page Charge of \$175 per page (beginning with page 9 and beyond) is required for articles in excess of eight printed pages. The purpose is to encourage tight editing and elimination of tutorial and background material from manuscripts and thus allow additional articles to be published within the annual page count limits for this TRANSACTIONS. Authors who cannot honor mandatory page charges will be requested to reduce their manuscripts to eight printed pages or less prior to final acceptance and scheduling for publication.

**Letters:** There will be no exceptions in regard to the 4-page maximum page limitation, and paying overlength page charges is not an option for Letters submission.
