# The first passage time density of Brownian motion and the heat equation with Dirichlet boundary condition in time dependent domains

#### Abstract

In 4], it is proved that we can have a continuous first-passage-time density function of one dimensional standard Brownian motion when the boundary is Hölder continuous with exponent greater than $1 / 2$. For the purpose of extending 4 into multidimensional domains, we show that there exists a continuous first-passage-time density function of standard $d$-dimensional Brownian motion in moving boundaries in $\mathbb{R}^{d}, d \geq 2$, under a $C^{3}$-diffeomorphism. Similarly as in [4], by using a property of local time of standard $d$-dimensional Brownian motion and the heat equation with Dirichlet boundary condition, we find a sufficient condition for the existence of the continuous density function.


## 1 Introduction

First passage time (FPT) problem, which is also called boundary crossing problem, is the one of classical subjects in probability which has also many applications to other fields, for example, finance and biology. There are a bunch of articles studying this problem, but especially we mention one of them, [4, which is about we can have a continuous first-passage-time density function of one dimensional standard Brownian motion when the boundary is Hölder continuous with exponent greater than $1 / 2$. The purpose of this paper is that we extend the result and the general strategy of [4] into the multidimensional domain, precisely, to find a continuous density function of the first hitting time in a time varying domain in $\mathbb{R}^{d}, d \geq 2$, by investigating a relation between the first passage time density and the derivative at the boundary of the solution of the heat equation with Dirichlet boundary condition. Thus this article is concerned with standard d-dimensional Brownian motion killed on the boundary of a deterministic moving domain which corresponds to the heat equation with Dirichlet boundary condition. In [1], it is studied for reflected Brownian motion whose analytic counterpart is the heat equation with Neumann boundary condition.

[^0]Unfortunately, in general, it is hard to obtain the explicit form of the density function. For one dimensional Brownian motion, some analytic solutions are introduced in 4]. For two dimensional Brownian motion, in [5], the analytical solution of the Laplace transform of FPT distributions and its inverse is done numerically and other existing literatures including applications to quantitative finance are also summarized.
The organization of this article is as follows: In Section 2, we set up the regularity of time dependent domain and state the main theorem containing the existence of the continuous density function which is proportional to the normal derivative at the boundary of the solution of the heat equation with Dirichlet boundary condition. In Section 3, we prove the weaker form of the main theorem to apply PDE techniques and Proposition 2, called the jump relation for our time varying domain that allows to have a implicit formula of the continuous density function that is an integral equation of Volterra type in Proposition 5. In Section 4, we prove the main theorem by comparing between the solution obtained by the probabilistic construction, called Feynman-Kac formula, and the one obtained by Green's formula.

## 2 Preliminaries: problem setting and main theorem

We start with the domain $\Omega$ which is a bounded connected open set in $\mathbb{R}^{d}, d \geq 2$. We denote by $\partial \Omega$ and $\bar{\Omega}$ the boundary of $\Omega$ and the closure of $\Omega$. $\Omega$ changes in time with respect to a continuous velocity vector field $v: \mathbb{R}^{d} \times \mathbb{R}_{+} \rightarrow \mathbb{R}^{d}$ such that there is a set of integral curves $\left\{\theta_{s}^{t}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}\right\}_{s \leq t}$ which satisfies $\frac{\partial \theta_{s}^{t} x}{\partial t}=v\left(\theta_{s}^{t} x, t\right)$ and $\theta_{s}^{s} x=x$ for all $x \in \mathbb{R}^{d}$. For the existence of $\theta_{s}^{t}$, we assume that for any finite interval $I \subset \mathbb{R}_{+}$, there is $L>0$ such that $\left|v\left(x_{1}, t\right)-v\left(x_{2}, t\right)\right| \leq L\left|x_{1}-x_{2}\right|$ for all $x_{1}, x_{2}$ in $\mathbb{R}^{d}$ and all $t \in I$. From now on, we restrict time domain to a finite interval $[0, T]$ for fixed $T>0$. Then we have

Proposition 1 There is a unique homeomorphism $\theta_{s}^{t}: \mathbb{R}^{d} \rightarrow \mathbb{R}^{d}$ for any $0 \leq s \leq t \leq T$, which satisfies $\frac{\partial \theta_{s}^{t} x}{\partial t}=v\left(\theta_{s}^{t} x, t\right)$ and $\theta_{s}^{s} x=x$ for all $x \in \mathbb{R}^{d}$.

Proof See Theorem 2.1 in Chapter 1 of [8] or Proposition 1.1 in Chapter 4 of [6].
Thus we can write $\theta_{s}^{t} x=x+\int_{s}^{t} v\left(\theta_{s}^{\tau} x, \tau\right) d \tau$ and let us write $\theta_{t}^{s}$ as the inverse of $\theta_{s}^{t}$. We denote by $\Omega_{t}$ the image of $\Omega$ under $\theta_{0}^{t}$, by abuse of notation, $\theta_{s}^{t}: \Omega_{s} \rightarrow \Omega_{t}$ is a homemorphism and then we can also extend the domain of $\theta_{s}^{t}$ into $\overline{\Omega_{s}}$ so that $\theta_{s}^{t}$ is a boundary-preserving mapping from $\overline{\Omega_{s}}$ to $\overline{\Omega_{t}}$.
Now we consider the initial-boundary value problem for the heat equation in moving domains $\left\{\Omega_{t}\right\}_{t \geq 0}$ as follows:

\end{array}\right.

To obtain a solution of (2.1), we have to find suitable conditions about the initial function $u_{0}$, the moving velocity $v$ and the boundaries $\partial \Omega_{t}$. In the next sections, we will approxi-
mate the Dirac delta function with a sequence of $C_{c}^{\infty}$－functions thus we assume that $u_{0}$ is $C_{c}^{\infty}$ and whose support is contained in $\Omega$ ．Moreover，we suppose that $\partial \Omega$ is $C^{3}$ ，that is，if for each point $x^{0} \in \partial \Omega$ there exist $r>0$ and a $C^{3}$ function $F: \mathbb{R}^{d-1} \rightarrow \mathbb{R}$ such that－upon relabeling and reorienting the coordinates axes if necessary－we have

where $\mathcal{B}(x, r)=\left\{y \in \mathbb{R}^{d}:|x-y|<r\right\}$ the open ball with center $x \in \mathbb{R}^{d}$ and radius $r>0$ throughout the paper．In addition，let us assume that $v$ is $C^{3}$ so that $\theta_{s}^{t} x(=\theta(x, t))$ is a function of $x$ and $t$ which is $C^{3}$ ，thus $\theta_{s}^{t}: \overline{\Omega_{s}} \rightarrow \overline{\Omega_{t}}$ is $C^{3}$－diffeomorphism（c．f．Chapter 4 of［6］）．Let us denote by the parabolic cylinder and the lateral boundary

Then we have the following existence theorem．
Theorem 1 （existence）There exists a unique solution $u$ of（2．1）such that $u \in C_{x, t}^{2,1}\left(\overline{D_{T}}\right)$ ．
Proof See Theorem 7 in Chapter 3 of 3］．

Remark 1 The assumption that $\partial \Omega$ and $v$ are $C^{3}$ is to have $\nabla_{x} u(\cdot, t)$ is bounded on $\Omega_{t}$ so that it can be continuously extended to $\overline{\Omega_{t}}$ which is essential in Theorem 圆 below．For the proof of Proposition 圆 and 图，it is enough that $\partial \Omega$ is $C^{2}$ and $v$ is $C^{2}$ with respect to spatial variable so that $\theta_{s}^{t}$ is $C^{2}$－diffeomorphism．

Let us call $P_{r, s}, r \in \mathbb{R}, s \geq 0$ ，the law on $C([s, \infty))$ of standard $d$－dimensional Brownian motion $B_{t}, t \geq s$ ，which starts from $r$ at time $s$ ，i．e．$B_{s}=r$ ．For each $t>s$ ，the law of $B_{t}$ is absolutely continuous with respect to the Lebesgue measure and has a density $G_{s, t}(r, \cdot)$ which is the Gaussian $G(\cdot, t ; r, s)=\left(\frac{1}{\sqrt{2 \pi(t-s)}}\right)^{d} \exp \left\{-\frac{(\cdot-r)^{2}}{2(t-s)}\right\}$ ．For $s \geq 0$ and $r \in \Omega_{s}$ ，we define

where $B_{s}=r$ and denote by $d F_{r, s}(y, q), y \in \partial \Omega_{q}$ ，the distribution of $\tau_{r, s}^{\Omega, v}$ induced by $P_{r, s}$ ．For $s=0$ ，we use abbreviated forms $P_{r}, E_{r}, \tau_{r}, d F_{r}(y, q)$ instead of $P_{r, 0}, E_{r, 0}, \tau_{r, 0}^{\Omega, v}$ ， $d F_{r, 0}(y, q)$ respectively whenever it is needed．In addition，for $r_{0} \in \Omega$ and $t>0$ ，let us call $d \mu_{r_{0}}(\cdot, t)$ the positive measure on $\Omega_{t}$ such that

for all $f \in C_{c}^{\infty}\left(\mathbb{R}^{d}\right)$ with $\operatorname{supp} f \Subset \Omega_{t}$ ．
Since $\partial \Omega_{t}$ is $C^{3}$ ，we have the outward pointing unit normal vector field $n=n_{x, t}$ at $x \in \partial \Omega_{t}$ and let us denote $\frac{\partial f}{\partial n}(x, t):=n \cdot \nabla_{x} f(x, t)$ for $f \in C_{x}^{1}\left(\overline{D_{T}}\right)$ ．Throughout the paper，we write $d \mathcal{H}^{d-1}$ as the $(d-1)$－dimensional Hausdorff measure on $\mathbb{R}^{d}$ ．The main result in the paper is；

Theorem 2 Under the same assumption as in Theorem [1, we have for any $r_{0} \in \Omega_{0}=\Omega$,

1. $d \mu_{r_{0}}(x, t)=G_{0, t}^{\Omega, v}\left(r_{0}, x\right) d x$ where for all $x \in \Omega_{t}$,

2. $d F_{r_{0}}(y, s)$ has a continuous density function $p$ such that $d F_{r_{0}}(y, s)=p(y, s) d \mathcal{H}^{d-1}(y) d s$.
3. $p(x, t)=-\frac{1}{2} \frac{\partial}{\partial n} G_{0, t}^{\Omega, v}\left(r_{0}, x\right)$ for all $t>0$ and $x \in \partial \Omega_{t}$.
4. $G_{0, t}^{\Omega, v}\left(r_{0}, x\right)$ solves

## 3 Weaker Form of Theorem [2

Let us first prove item 1 of Theorem 2. By (2.5) and the strong Markov property of Brownian motion,

& =\int_{\Omega_{t}} f(x) G_{0, t}\left(r_{0}, x\right) d x-\int_{[0, t)} \int_{\partial \Omega_{s}} E_{y, s}\left[f\left(B_{t}\right) \mid B_{s}=y, \tau_{r_{0}}^{\Omega, v}=s\right] d F_{r_{0}}(y, s) \\
& =\int_{\Omega_{t}} f(x) G_{0, t}\left(r_{0}, x\right) d x-\int_{\Omega_{t}} f(x) \int_{[0, t)} \int_{\partial \Omega_{s}} G_{s, t}(y, x) d F_{r_{0}}(y, s) d x \\
& =\int_{\Omega_{t}} f(x)\left(G_{0, t}\left(r_{0}, x\right)-\int_{[0, t)} \int_{\partial \Omega_{s}} G_{s, t}(y, x) d F_{r_{0}}(y, s)\right) d x \tag{3.10}
\end{align*}

Thus the proof is done. Before proving the other items of Theorem 2, we study the weaker form of it that we will specify below because the initial datum of item 4 is the Dirac delta function which is hard to control directly so that we let it as $C_{c}^{\infty}$ and apply approximation as usual. By item 1 of Theorem 2 we have $G_{0, t}^{\Omega, v}$ so let us define

for given $u_{0} \in C_{c}^{\infty}\left(\Omega ; \mathbb{R}_{+}\right)$and all $(x, t) \in D$.
We prove the following weaker form of Theorem 2,
Theorem 3 Under the same assumption as in Theorem 1, we have

1. The function $u$ defined in (3.11) is the unique solution of Theorem 1 .
2. Moreover, for all $t>0, p_{u_{0}}(x, t):=-\frac{1}{2} \frac{\partial u}{\partial n}(x, t)$ satisfies

Before going to the proof of Theorem 3, we will prove Proposition 2 and Proposition 3 below, as mentioned in Remark [1, we assume that $\partial \Omega$ is $C^{2}$ and $v$ is $C^{2}$ with respect to spatial variable. First the following Lemma 1 and 2 are needed for Proposition 2,

Lemma 1 There is $C>0$ such that for all $0 \leq t \leq T$ and all $x \in \partial \Omega_{t}$, we have

if $y \in \partial \Omega_{t}$ is sufficiently close to $x$.
Proof First we fix $0 \leq t \leq T$ and $x \in \partial \Omega_{t}$. There is a local representation $F \in C^{2}$ at $x$, without loss of generality, we may assume that $x=0$ and $D F(x)=0$ such that all $y \in \partial \Omega_{t}$ sufficiently close to $x$ can be written as $y=\left(y_{1}, \cdots, y_{d}\right)=\left(y_{1}, \cdots, y_{d-1}, F\left(y_{1}, \cdots, y_{d-1}\right)\right)$. By Taylor's theorem, we have

Thus the boundaries $\left\{\partial \Omega_{t}\right\}_{0 \leq t \leq T}$ are compact and diffeomorphic to each other under $\theta$ so that the second differential of a local representation is uniformly bounded. The proof is complete.

Lemma 2 Given $\epsilon>0$, there is $\delta>0$ such that for all $0<t \leq T$ and all $x \in \partial \Omega_{t}$,

Proof We fix $0<t \leq T$ and $x \in \partial \Omega_{t}$. For a local representation $F \in C^{2}$ at $x$, without loss of generality, we may assume that $x=0$ and $D F(x)=0$ such that all $y \in \partial \Omega_{t}$ sufficiently close to $x$ can be written as $y=\left(y_{1}, \cdots, y_{d}\right)=\left(y_{1}, \cdots, y_{d-1}, F\left(y_{1}, \cdots, y_{d-1}\right)\right)$. Let us choose $\gamma$ and $\eta$ such that $\frac{1}{4}<\gamma<\frac{1}{2}$ and $\eta>\frac{\sup }{D_{T}}|v|$. We define $E_{s}^{1}:=\partial \Omega_{s} \cap \mathcal{B}(x, \eta(t-$ $\left.s)^{\gamma}\right), E_{s}^{2}:=\partial \Omega_{s}-E_{s}^{1}$. Then $\theta_{t}^{s} x \in E_{s}^{1}$ for all $s$ sufficiently close to $t$. By a change of
variables, we obtain

& =\int_{\theta_{s}^{t}\left(E_{s}^{1}\right)}\left(\frac{1}{\sqrt{2 \pi(t-s)}}\right)^{d-1} \exp \left\{-\frac{|y|^{2}}{2(t-s)}\right\} d \mathcal{H}^{d-1}(y) \\
& =\int_{P\left(\theta_{s}^{t}\left(E_{s}^{1}\right)\right)}\left(\frac{1}{\sqrt{2 \pi(t-s)}}\right)^{d-1} \exp \left\{-\frac{\sum_{i=1}^{d-1}\left|y_{i}\right|^{2}+\left|F\left(y_{1}, \cdots, y_{d-1}\right)\right|^{2}}{2(t-s)}\right\} \sqrt{|A|} d y_{1} \cdots d y_{d-1}, \tag{3.16}

where Jac is a Jacobian matrix and $P$ is a projection such that $P\left(y_{1}, \cdots, y_{d}\right)=\left(y_{1}, \cdots, y_{d-1}\right)$ and $A$ is a $(d-1) \times(d-1)$-matrix whose element $a_{i j}$ is given by $\delta_{i j}+\frac{\partial F}{\partial y_{i}} \frac{\partial F}{\partial y_{j}}$.
If $y \in E_{s}^{1}$, then $\left|\theta_{s}^{t} y\right|^{2}=|y|^{2}+2\left|\left\langle y, \int_{s}^{t} v\left(\theta_{s}^{\tau} y, \tau\right) d \tau\right\rangle\right|+\left|\int_{s}^{t} v\left(\theta_{s}^{\tau} y, \tau\right) d \tau\right|^{2} \leq|y|^{2}+2 \eta^{2}(t-$ $s)^{1+\gamma}+\eta^{2}(t-s)^{2}$ and $\left|\operatorname{Jac}\left(\theta_{s}^{t} y\right)\right|=\left|\left[\delta_{i j}+\int_{s}^{t} \frac{\partial}{\partial y_{j}}\left(v^{(i)}\left(\theta_{s}^{\tau} y, \tau\right)\right) d \tau\right]\right|$. Thus for given $\epsilon>0$, there is $\delta_{1}>0$ which does not depend on the choice of $(x, t)$ such that for all $t-\delta_{1}<s<t$,

If $\left(y_{1}, \cdots, y_{d-1}\right) \in P\left(\theta_{s}^{t}\left(E_{s}^{1}\right)\right)$, then $\left|\theta_{t}^{s}\left(y_{1}, \cdots, y_{d-1}, F\left(y_{1}, \cdots, y_{d-1}\right)\right)\right| \leq \eta(t-s)^{\gamma}$. So we have $\left|\left(y_{1}, \cdots, y_{d-1}\right)\right| \leq 2 \eta(t-s)^{\gamma}$ for all $s$ sufficiently close to $t$, thus

By the mean value theorem, we get

Since the second differential of a local representation is uniformly bounded, for given $\epsilon>0$, there is $\delta_{2}>0$ which does not depend on the choice of $(x, t)$ such that for all $t-\delta_{2}<s<t$,

Moreover, if $\left|\left(y_{1}, \cdots, y_{d-1}\right)\right| \leq \frac{\eta}{2}(t-s)^{\gamma}$, then $\left(y_{1}, \cdots, y_{d-1}\right) \in P\left(\theta_{s}^{t}\left(E_{s}^{1}\right)\right)$ for all $s$ sufficiently close to $t$, so for given $\epsilon>0$, there is $\delta_{3}>0$ which does not depend on the choice
of $(x, t)$ such that for all $t-\delta_{3}<s<t$,

We develope it into a multidimensional case under the assumption discussed above and give a rigorous calculation.

The following Proposition depends on a local property of Brownian motion and the regularity of the boundary whose one dimensional version is done in [4], which is about the accessibility of the boundary necessary to show Dirichlet boundary condition in Theorem 3.

Proposition 3 If the starting point of Brownian motion is close to $X$, the first passage time converges to 0. Precisely, $\lim _{\Omega_{0} \ni \xi \rightarrow \xi_{0} \in \partial \Omega_{0}} P_{\xi}\left[\tau_{\xi}^{\Omega, v}>s\right]=0$ for all $s>0$.

Proof Without loss of generality, we may assume that $0 \in \partial \Omega_{0}$ and the tangent plane of $\partial \Omega_{0}$ at 0 and $e_{d}$ is the outward unit normal vector at 0 . A standard $d$-dimensional Brownian motion $B_{t}=\left(B_{t}^{(1)}, \cdots, B_{t}^{(d)}\right)$ which starts at $\xi=\left(\xi^{(1)}, \cdots, \xi^{(d)}\right)$. Since $\theta_{t}^{0}$ is a diffeomorphim, $B_{t}$ is out of $\Omega_{t}$ if and only if $\theta_{t}^{0} B_{t}=B_{t}-\int_{0}^{t} v\left(\theta_{t}^{s} B_{t}, s\right) d s$ is out of $\Omega_{0}$. We have $a>0$ such that $\mathcal{B}(0, a) \cap \partial \Omega_{0}=\left\{x \in \mathbb{R}^{d}: x^{(d)}=F\left(x^{(1)}, \cdots, x^{(d-1)}\right)\right\}$ for some $F \in C^{2}$. Thus there is $c>0$ which does not depend on $a$ such that if $x \in \mathcal{B}(0, a) \cap \partial \Omega_{0}$, then $\left|x^{(d)}\right| \leq c a^{2}$. Since sup $|v|<\eta$, we have

Thus by Proposition 2, we have $u(x, t) \rightarrow 0$ as $x$ approaches to $\partial \Omega_{t}$.
Let us prove that $u$ satisfies the initial data $u_{0}$, that is, $\lim _{(x, t) \rightarrow(y, 0)} u(x, t)=u_{0}(y)$ for all $y \in \Omega_{0}$. Fix $y \in \Omega_{0}$ and without loss of generality, we may assume that $y=0$ by shifting the origin. For any $x \in \Omega_{0}$ and any positive $\lambda>0$,

& =P_{x}\left[\max _{s \in[0, t]} \exp \left\{\lambda\left|B_{s}\right|\right\} \geq \exp \left\{\lambda\left(d\left(x, \partial \Omega_{t}\right)-|x|-\eta t\right)\right\}\right] . \tag{3.42}
\end{align*}

Since $\exp \left\{\lambda\left|B_{t}\right|\right\}$ is a positive submartingale, we can apply Doob's inequality, then

=\int_{\partial \Omega_{s}}-G(x, t ; y, s) \frac{\partial u}{\partial n}(y, s) d \mathcal{H}^{d-1}(y) . \tag{3.47}

By integrating the last two terms of (3.47) with respect to $s$ from 0 to $t$, we obtain another different representation of $u$ as follows:

Proposition $4 d F_{u_{0}}(y, s)=-\frac{1}{2} \frac{\partial u}{\partial n}(y, s) d \mathcal{H}^{d-1}(y) d s$.
For the proof of Proposition 4, we introduce the mass lost $\Delta_{I}^{\Omega, v}(u), I=\left[t_{1}, t_{2}\right] \subset[0, T]$, $t_{1} \leq t_{2}$, is defined by

Then this satisfies the heat equation with $\lim _{(x, t) \rightarrow(y, 0)} \bar{u}(x, t)=0$ for all $y \in \Omega_{0}^{c}$ and also satisfies $\bar{u}(x, t)=0$ for all $0<t \leq T$ and all $x \in \partial \Omega_{t}$. Moreover, by the properties of Gaussian kernel, we have

Since we do not control $\Delta_{x} u$ at the moving boundary, we cannot make this argument rigorously. Thus we use a different approach.

\end{aligned}

For $0<t_{1}<t_{2}$, similarly,

& =\int_{\Omega_{0}} u_{0}(\xi) P_{\xi}\left[t_{1} \leq \tau_{\xi}^{\Omega, v}<t_{2}\right] d \xi
\end{aligned}
$$

Then for $I_{\epsilon}=\left[t_{2}, t_{2}+\epsilon\right]$, we get

& =\int_{\Omega_{0}} u_{0}(\xi) P_{\xi}\left[\tau_{\xi}^{\Omega, v}=t_{2}\right] d \xi .

Proposition 5 Let us assume the starting point of Brownian motion $r_{0}=0 \in \Omega_{0}$ and let us choose a sequence $\left\{h_{m}\right\} \subset C_{c}^{\infty}\left(\mathbb{R}^{d} ; \mathbb{R}_{+}\right)$with supp $h_{m}=\mathcal{B}\left(0, \frac{1}{m}\right) \Subset \Omega_{0}$ and $\left\|h_{m}\right\|_{1}=1$. For each $h_{m}$, there exists a corresponding solution $u_{m}$ with $-\frac{1}{2} \frac{\partial u_{m}}{\partial n}(x, t)=: p_{m}(x, t)$ in the sense of Theorem [3. Then we have the following statements:

1. There is a unique $p \in C\left(S_{T}\right)$ with $p(\cdot, 0)=0$ such that for all $t>0$ and all $x \in \Omega_{t}$,

Now we have $p_{T_{s}}$ for some $T_{s}>0$. For $T^{\star}>T_{s}$, let us denote $S_{\left[T_{s}, T^{\star}\right]}:=\bigcup_{T_{s} \leq t \leq T^{\star}} \partial \Omega_{t} \times\{t\}$.
We define $\mathcal{K}: C\left(S_{\left[T_{s}, T^{\star}\right]}\right) \rightarrow C\left(S_{\left[T_{s}, T^{\star}\right]}\right)$ as, for $q \in C\left(S_{\left[T_{s}, T^{\star}\right]}\right)$,

\end{aligned}

Then for $q_{1}, q_{2} \in C\left(S_{\left[T_{s}, T^{\star}\right]}\right)$, we have

Therefore, if we have $p$ defined $S_{T_{s}}, p_{T_{s}}$, then we can extend this to time $T_{s}+C_{3}$ where $C_{3}$ is a constant. Thus if we repeat this step inductively, we have $p$ defined on $S_{T}$ which satisfies 4.58).
We now prove that $p_{m}$ converges to $p$ in sup norm for all sufficiently small $T_{s}>0$. By (3.12),

Let us denote $\left\|p_{m}-p\right\|_{T_{s}}:=\sup _{\tau \in\left[0, T_{s}\right]} \sup _{y \in \partial \Omega_{\tau}}\left|p_{m}(y, \tau)-p(y, \tau)\right|$. For the second term of the right hand side, we have

& =C_{5} t^{2 \gamma-\frac{1}{2}}\left\|p_{m}-p\right\|_{T_{s}} \leq C_{5} T_{s}^{2 \gamma-\frac{1}{2}}\left\|p_{m}-p\right\|_{T_{s}}
\end{aligned}
$$

Let us choose $T_{s}>0$ such that $C_{5} T_{s}^{2 \gamma-\frac{1}{2}}<1$. Then

& \leq \sup _{0<t \leq T_{s}} \sup _{x \in \partial \Omega_{t}} \sup _{|\xi| \leq \frac{1}{m}}\left|\frac{\partial G}{\partial n_{x, t}}(x, t ; \xi, 0)-\frac{\partial G}{\partial n_{x, t}}(x, t ; 0,0)\right| .
\end{aligned}

& \left|\partial_{i}^{2} G(x, t ; \xi, 0)\right| \leq \frac{C_{7}}{t^{\frac{d}{2}+1}}, \\
& \left|\partial_{j} \partial_{i} G(x, t ; \xi, 0)\right|=\left|\frac{\left(\xi_{i}-x_{i}\right)\left(\xi_{j}-x_{j}\right)}{t^{2}}\left(\frac{1}{\sqrt{2 \pi t}}\right)^{d} \exp \left\{-\frac{|x-\xi|^{2}}{2 t}\right\}\right| \leq \frac{C_{8}}{|x-\xi|^{d+2}}, \\
& \left|\partial_{j} \partial_{i} G(x, t ; \xi, 0)\right| \leq \frac{C_{9}}{t^{\frac{d}{2}+1}} . \tag{4.63}
\end{align*}

For all sufficiently small $T_{s}$ and all sufficiently large $m$, by the mean value theorem and (4.63), there exists $C_{10}>0$ such that for all $|\xi| \leq \frac{1}{m}$,

To extend from $T_{s}$ to $T^{\star}$, assuming that $p_{m}$ converges to $p$ in $C_{S_{T_{s}}}$ for some $T_{s}>0$ and writing $\left\|p_{m}-p\right\|_{\left[T_{s}, T^{\star}\right]}=\sup _{\tau \in\left[T_{s}, T^{\star}\right]} \sup _{y \in \partial \Omega_{s}}\left|p_{m}(y, \tau)-p(y, \tau)\right|$, for $T_{s} \leq t \leq T^{\star}$, we deduce
that by the mean value theorem and (4.63),

$$
\begin{aligned}
\left|p_{m}(x, t)-p(x, t)\right| & \leq\left|\int_{\Omega_{0}} h_{m}(\xi)\left(\frac{\partial G}{\partial n_{x, t}}(x, t ; \xi, 0)-\frac{\partial G}{\partial n_{x, t}}(x, t ; 0,0)\right) d \xi\right| \\
& +\left|\int_{0}^{T_{s}} \int_{\partial \Omega_{\tau}} \frac{\partial G}{\partial n_{x, t}}(x, t ; y, \tau)\left(p_{m}(y, \tau)-p(y, \tau)\right) d \mathcal{H}^{d-1}(y) d \tau\right| \\
& +\left|\int_{T_{s}}^{t} \int_{\partial \Omega_{\tau}} \frac{\partial G}{\partial n_{x, t}}(x, t ; y, \tau)\left(p_{m}(y, \tau)-p(y, \tau)\right) d \mathcal{H}^{d-1}(y) d \tau\right| \\
& \leq \frac{C_{11}}{m T_{s}^{\frac{d}{2}+1}}+C_{1} \int_{0}^{T_{s}} \frac{\left\|p_{m}-p\right\|_{T_{s}}}{(t-\tau)^{\frac{3}{2}-2 \gamma}} d \tau+C_{1} \int_{T_{s}}^{t} \frac{\left\|p_{m}-p\right\|_{\left[T_{s}, T^{\star}\right]}}{(t-\tau)^{\frac{3}{2}-2 \gamma}} d \tau \\
& \leq \frac{C_{11}}{m T_{s}^{\frac{d}{2}+1}}+C_{1} \int_{0}^{T_{s}} \frac{\left\|p_{m}-p\right\|_{T_{s}}}{\left(T_{s}-\tau\right)^{\frac{3}{2}-2 \gamma}} d \tau+C_{12}\left\|p_{m}-p\right\|_{\left[T_{s}, T^{\star}\right]}\left(t-T_{s}\right)^{2 \gamma-\frac{1}{2}} \\
& \leq \frac{C_{11}}{m T_{s}^{\frac{d}{2}+1}}+C_{13} T_{s}^{2 \gamma-\frac{1}{2}}\left\|p_{m}-p\right\|_{T_{s}}+C_{12}\left\|p_{m}-p\right\|_{\left[T_{s}, T^{\star}\right]}\left(T^{\star}-T_{s}\right)^{2 \gamma-\frac{1}{2}} .
\end{aligned}
$$

Let us choose $T^{\star}>T_{s}$ such that $C_{12}\left(T^{\star}-T_{s}\right)^{2 \gamma-\frac{1}{2}}<1$, then we have

$$
\left(1-C_{12}\left(T^{\star}-T_{s}\right)^{\gamma-\frac{1}{2}}\right)\left\|p_{m}-p\right\|_{\left[T_{s}, T^{\star}\right]} \leq \frac{C_{11}}{m T_{s}^{\frac{d}{2}+1}}+C_{13} T_{s}^{2 \gamma-\frac{1}{2}}\left\|p_{m}-p\right\|_{T_{s}}
$$

The right term vanishes when $m$ goes to $\infty$ so that $p_{m}$ converges to $p$ in $C\left(S_{T_{s}+C_{14}}\right)$ for some constant $C_{14}>0$. By repeating this argument inductively, it follows that $p_{m}$ converges to $p$ in sup norm.

Now we can show that $p$ is the continuous density function of $d F_{r_{0}}$.
By Proposition 5, we have

$$
\lim _{m \rightarrow \infty} \int_{\Omega_{0}} h_{m}(\xi) P_{\xi}\left(\tau_{\xi}^{\Omega, v} \in I\right) d \xi=\lim _{m \rightarrow \infty} \int_{I} \int_{\partial \Omega_{t}} p_{m}(x, t) d t=\int_{I} \int_{\partial \Omega_{t}} p(x, t) d t
$$

For $I=[0, t] \subset[0, T]$, therefore, we obtain that

$$
\begin{equation*}
\int_{[0, t]} \int_{\partial \Omega_{s}} d F_{r_{0}}(y, s)=P_{r_{0}}\left(\tau_{r_{0}}^{\Omega, v} \leq t\right)=\int_{0}^{t} \int_{\partial \Omega_{s}} p(y, s) d s, \tag{4.64}
\end{equation*}
$$

which implies that $p$ is the continuous density function of $d F_{r_{0}}(y, s)$, thus item 2 is proved. By Theorem 1 and the properties of the Gaussian kernel, $G_{0, t}^{\Omega, v}\left(r_{0}, x\right)$ solves (2.7), (2.8) and (2.9). Hence $G^{\Omega, v}$ is the Green function of the heat equation with Dirichlet boundary condition which implies item 4 Furthermore, $G_{0, t}^{\Omega, v}\left(r_{0}, x\right)$ can be written as

$$
\begin{equation*}
G_{0, t}^{\Omega, v}\left(r_{0}, x\right)=G_{0, t}\left(r_{0}, x\right)-\int_{0}^{t} \int_{\partial \Omega_{\tau}} G_{\tau, t}(y, x) p(y, \tau) d \mathcal{H}^{d-1}(y) d \tau . \tag{4.65}
\end{equation*}
$$

Taking a normal derivative with respect to x , applying the jump relation and (4.58), we have

$$
\begin{align*}
\frac{\partial}{\partial n} G_{0, t}^{\Omega, v}\left(r_{0}, x\right) & =\frac{\partial}{\partial n} G_{0, t}\left(r_{0}, x\right)-p(x, t)-\int_{0}^{t} \int_{\partial \Omega_{\tau}} \frac{\partial}{\partial n} G_{\tau, t}(y, x) p(y, \tau) d \mathcal{H}^{d-1}(y) d \tau \\
& =-2 p(x, t) . \tag{4.66}
\end{align*}
$$

Thus $p(x, t)=-\frac{1}{2} \frac{\partial}{\partial n} G_{0, t}^{\Omega, v}\left(r_{0}, x\right)$, so it proves item 3 of Theorem 2,
